1	High hydrogen production rate in a submerged membrane anaerobic bioreactor

11	Abstract:
12	Batch cultivation of an anaerobic consortium fed with glucose as sole carbon source
13	showed a sharp decrease of the hydrogen productivity when volatile fatty acids (VFA)
14	concentration exceeded 12.5g.L ⁻¹ . To avoid VFA accumulation, fermentative batch
15	cultures were thereafter carried out with a submerged membrane anaerobic bioreactor to
16	continuously remove hydrogen fermentation co-products, while retaining the biomass.

17 The membrane made it possible to separate the residence times of bacterial biomass and

18 hydraulic part. With this technology, average and maximal productivities reached 0.75

and 2.46 L_{H2} .L^{-1.}h⁻¹, corresponding to an increase of 44 and 51% in comparison to the

20 control, respectively. By removing the VFAs from the cultivation medium, H₂-

21 producing pathways were favored, confirming the metabolic inhibitory effects of co-

22	product accumulation in fermentation medium. Such hydrogen productivity is one of
23	the highest values encountered in the literature. Readily implementable, such
24	technology offers a good opportunity for further developing high rate hydrogen
25	fermentation bioprocesses.

30 1. Introduction

31 Over the past decade, progressive exhaustion of fossil fuels and raising awareness on 32 the ecological risks associated to their use have resulted in numerous scientific studies 33 aiming to find alternative solutions. Hydrogen production has been particularly studied. 34 Indeed, H₂ molecule has a high calorific value (142 MJ/kg), twice the energetic 35 potential of natural gas [1]. Moreover, water is the only residue released by combustion. 36 Hydrogen demand should therefore increase in the coming years [2,3] following the 37 wide development of fuel cells in many domains such as transportation, multimedia, 38 aerospace and civil engineering [4]. All these characteristics feature hydrogen as a 39 serious alternative to fossil fuels.

40 Nowadays, 95% of the hydrogen comes from fossil fuels [5], making essential to find41 alternative methods.

42 Dark fermentation is a great process to produce biohydrogen. The principle is similar to biogas production by anaerobic digestion as the DF is based on a chain of successive 43 44 reactions. First, some bacteria such as *Clostridia* [6] have the ability to hydrolyze 45 organic material and release simple sugars and amino acids. These products are then 46 converted into volatile fatty acids and alcohols through various metabolic pathways, socalled acidogenesis. Only two metabolic pathways are inducing hydrogen production, 47 48 the acetate and butyrate pathways [7]. In mixed culture where different metabolic pathways could occur, an average reaction was previously proposed [8]: 49

50 $4C_6H_{12}O_6 + 2H_2O \rightarrow 3CH_3(CH_2)_2COOH + 2CH_3COOH + 8CO_2 + 10H_2$ (eq. 1)

Hydrogen is produced with hydrogenase [Fe-S] which catalyses NADH oxidation and
reduction of two H⁺ into H₂. The main advantage of performing DF with mixed culture

is the ability of anaerobic bacteria to degrade many complex substrates such as
agricultural residues, lignocellulosic biomass, wastes, industrial and domestic effluents
[9]. Moreover, the VFAs co-produced during the culture correspond to high added value
platforms molecules that have many industrial applications [10] or potential substrate to
lipid production [11].

58 In mixed culture, culture conditions are crucial and have to be optimized first to select 59 only hydrogen producing bacteria (HPB) and further improve hydrogen yields and 60 productivities. In particular, the pH is of utmost importance and should be maintained 61 between 5.2 and 7. Outside this range, hydrogen production decreases because 62 competing pathways are favoured [12]. For a pH below 5.2 and above 7, propionate and lactate can accumulate or solventogenesis reactions can occur inducing the 63 accumulation of acetone, butanol and ethanol (ABE fermentation). Overall, the 64 metabolites produced at that pH can also vary according to the microorganisms, the 65 66 substrates and the operating conditions. Culture medium composition has also to be optimized to ensure sufficient quantity of macro and micro-elements, and adequate C/N 67 and C/P ratio [13]. Iron is also a key factor to hydrogen production since it triggers the 68 69 activation of the hydrogenases [14,15].

One of the major drawbacks of hydrogen production by DF is the presence of inhibitors that can accumulate during the culture. The first one is the hydrogen itself through the H_2 partial pressure. Indeed, hydrogen production becomes thermodynamically unfavour when hydrogen partial pressure is higher than 10^{-3} atm [7] resulting in a loss of productivity. To limit the impact of hydrogen partial pressure, conventional techniques like flushing the bioreactor with inert gases (carbon dioxide, nitrogen, argon) [16,17] or increasing the stirring rate can be used [18]. More recently, Gas Separation Membrane Bioreactor was designed to improve hydrogen production capacity by stripping the
CO₂-concentrated fraction of the membrane separation unit to decrease hydrogen partial
pressure [19].

In addition, VFAs, as co-products, can accumulate in the liquid phase during the 80 81 reaction and have a detrimental effect on H₂ production. VFAs do not have the same 82 impact depending on their dissociation state. At pH 6 as commonly used, VFAs are in 83 majority dissociated since the pKa of these compounds is close to 4.8. Thereby their presence in the extracellular medium increases the osmotic pressure which in turn can 84 85 lead to cellular lysis of hydrogen-producing microorganisms [20]. Although VFAs toxicity has been clearly established in the literature, precisely 86 87 measuring the inhibition threshold for hydrogen production remains challenging, because it is strongly correlated to the culture conditions as well as the microbial 88 community. To prevent accumulation of VFAs in the medium, a classical Completely 89 Stirred Tank Reactors (CSTR) conducted in a continuous mode allow to control the 90 91 concentration of VFAs. However, maintaining the concentration below the toxicity 92 threshold of VFAs also implies a limitation of the biomass concentration and hence the 93 productivity of H₂.

Using Anaerobic Membrane Bioreactors (AnMBR) can be an interesting technology to
limit the accumulation of VFAs while maintaining the biomass in the medium. Several
configurations (internal or external immersed membrane and non-immersed membrane),
design (tubular, plate and frame, rotary disk or hollow fiber), materials (organic,
inorganic, and metallic) and pore size are available [10,21,22].

99 The objective of the present study is to determine thanks to this technology the VFAs 100 toxicity threshold and propose a technical concept to improve hydrogen production. 101 Here, the novelty is to use a submerged anaerobic membrane bioreactor which allows to 102 withdraw continuously the reaction medium containing hydrogen fermentation co-103 products. The biomass can accumulate into the bioreactor since the membrane cut-off is below microorganism size. In anaerobic culture, cell recycling remains an interesting 104 105 approach mainly because the quantity of biomass produced as well as the growth rate 106 are generally low. Finally the performances of hydrogen production with and without this technology are compared. 2. Materials and methods 107

108 2.1 Microorganisms

The microbial consortium was derived from sewage treatment plant sludge. A culture
was first carried out in complete medium, 2-bromoethanesulfonate (10mM) was added
to remove Archaea responsible for methane production [24] and then several
subcultures (10% v/v) were performed to stabilize and store the consortium.

113 2.2 Culture medium

114 The culture medium was adapted from Gaudet et al. (1992) [25]. The minerals

115 composition was $(g.L^{-1})$: $(NH_4)_2SO_4$ 5.4; FeCl₂,4H₂O 3.75; K₂HPO₄ 1.35; KH₂PO₄

116 1.35; NaCl 0.9; ZnCl₂ 0.41; H₃BO₃, H₂O 0.3; NiCl₂, 6H₂O 0.13; Na₂MoO₄, H₂O 0.13;

117 $CuCl_{2,2}H_{2}O \ 0.075$; Hemin 10^{-3} ; MgSO₄,7H₂O 2.4.10⁻⁴; CaCl₂,2H₂O 2.4.10⁻⁴; biotin

118 2.10⁻⁴; PABA 10⁻⁴; FeSO₄,7H₂O 8.10⁻⁵; MnSO₄,6H₂O 3.10⁻⁵; CoCl₂,6H₂O 3.10⁻⁶.

119 Glucose concentration was 8 and 60 $g.L^{-1}$ for the precultures and bioreactor medium

- respectively. After sterilization, medium was flushed with CO₂ and L-cysteine was
- 121 added to facilitate oxygen elimination. Na₂CO₃ was simultaneously added to fix the pH

at 6 and 7 for the bioreactor and precultures medium, respectively. The pH was higher
in preculture to avoid solventogenesis, occurring when pH decreases along with VFAs
accumulation [26].

- 125 2.3 Bioreactor culture
- 126 The culture was carried out in a submerged anaerobic membrane bioreactor of 7L
- 127 (GPC-Bio) with 5L of working volume. The 500 mL inoculum represented 10% (v/v) of

the bioreactor. The culture parameters were as follows: temperature 35°C, stirring rate

129 100 rpm, pH regulated at 6 by KOH (5 mol. L^{-1}) and/or H₂SO₄ (4 mol. L^{-1}) addition.

130 Two types of culture were performed: in batch (without membrane) or in sequential

131 continuous mode with the use of a submerged membrane bioreactor (BAMI culture). In

this second operation, one liter of liquid reaction medium containing VFAs was

withdrawn after 11; 12.5; 14.4; 16.3; 18.7 hours of culture and was replaced by fresh

134 medium.

135 2.4 Characterization of submerged anaerobic membrane bioreactor

136 The submerged membrane was previously described and characterized by Trad et al.

137 (2015) [27]. It was composed of 142 polymeric hollow fibers in PolyVinyliDene

138 Fluoride (PVDF) with 0.2 μ m cut-off. The membrane length was 32.5 cm and the

exchange area was 0.155 m^2 . The external loop volume was 0.5 L. The reaction medium

140 was continuously circulated in the membrane module with a recirculation pump

141 (Watson Marlow Qdos 30 Universal+) at the constant flow rate of 395.3 mL.min⁻¹. The

142 fibers of the membrane module were connected to a withdrawal pump (Ismatec 1076A)

143 for medium culture extraction at flow rate of 40 mL.min⁻¹. Analysis of the permeate

144	indicate a VFAs recovery yield of 97.2% [11]. During withdrawal of the supernatant,
145	the membrane was clogged by the biomass present on the fibers surface. To maintain a
146	constant flow rate, cleaning method was performed according the model developed in
147	our laboratory by Trad et al. (2015) [27] . The membrane was periodically flushed for
148	five minutes under a CO_2 flow rate of 0.2 to 0.3 L.min ⁻¹ , depending on the degree of
149	clogging. During the first two minutes of this operation, backwashing with extracted
150	supernatant was performed at the same time for more efficient unclogging. These
151	maintenance operations were renewed every 15 minutes.
152	2.5 Analytical methods
153	2.5.1 Gas phase
154	Biogas volume and flow rate were measured with a drum-type gas meter (Ritter TG05).
155	RIGAMO [®] software was used for analysis and real-time monitoring. Biogas
156	composition analysis was carried out with a micro-GC (Agilent 3000) equipped by two
157	channels and a thermal conductivity detector (TCD). The composition in hydrogen,
158	oxygen, nitrogen and methane was determined from the first channel with a molecular
159	sieve column (5Å). Argon was used as a vector gas at a pressure of 30 psi, the injector
160	and oven temperatures were respectively 80 and 90°C. Carbon dioxide and hydrogen
161	sulfur were determined by the other channel with a Pora plot U (PPU) column.
162	Hydrogen was the vector gas at a pressure of 30 psi, the temperatures of the injector and
163	of the column were 80 and 60°C, respectively. The software SOPRANE [®] provided to
164	SRA instruments was used to set parameters of gas chromatograph and analyze results
165	of gas composition.

The hydrogen production curves were modelled by the modified Gompertz model
primarily designed for pure batch cultures [26,28]. The model was described by the
following equation:

$$H = P \exp \{-\exp \left[\frac{Rm.\exp(1)}{P} (\lambda - t) + 1\right]\} \quad (eq. 2)$$

where H represented the cumulated hydrogen production (L), P the potential hydrogen production (L), Rm the maximal flow rate of hydrogen production (L.h⁻¹), λ the lag phase duration (h) and t the time (h).

174 The parameters P, Rm and λ were estimated by the solver function of Microsoft Office 175 Excel 2007 software. This function used the Newton algorithm calibrated with 100 176 iterations, 10⁻⁶ precision, 10⁻⁴ convergence and 5% tolerance to fit with experimental 177 values.

178 2.5.2 Liquid phase

179 The glucose and VFAs concentrations were determined in filtered aliquots of the culture by HPLC. The HPLC equipment (Agilent 100, Agilent Technology) was composed of 180 two columns (Rezex ROA 300x7.8 nm, Phenomenex, USA) mounted in serial in an 181 oven (50°C), and coupled to a refractometer as detector. The mobile phase consisted of 182 2 mM sulfuric acid in ultra-pure water pumped at 0.7 mL.min⁻¹ and 70 bars (7000 kPa). 183 184 For the analysis, 2 mL of sample were mixed with 250 µL of Ba(OH)₂, 8H₂O (0.3 M) and 250 µL of ZnSO₄, 7H₂O (5% w/v). The mixture was centrifuged at 10 000 g for 5 185 186 minutes. The supernatant was filtered through a 0.2 µm cellulose acetate filter and 187 injected in the HPLC.

- 188 2.5.3 Solid phase (Biomass)
- 189 During culture, the biomass was estimated by centrifugation of 5 mL of sample at
- 190 10000 g during 10 minutes. Cell dry weight was obtained by drying the sample in pre-
- 191 weighed tubes in an oven at 110° C until a constant weight was reached.
- 192 Six experimental times were selected for Single Strand Conformation Polymorphism
- 193 (SSCP) and quantitative PCR (qPCR) analysis: inoculation, start of gas production,
- 194 maximal gas production rate, stationary phase, beginning of the decrease in gas
- 195 production rate and end of gas production.
- 196 DNA extraction was carried out with Fast DNA SPIN Kit for Soil (MP Bio) from one
- 197 milliliter sample. DNA quantity and purity were assessed by spectrophotometry
- 198 (Infinite NanoQuant M200, Tecan).
- ARNr 16s of V3 region was amplified with *Escherichia coli* position F331
- 200 (ACGGTCCAGACTCCTACGGG) and R500 (TTACCGCGGCTGCTGGCAC)
- primers. The mix PCR was described by Saur et al. (2015) [29] and PCR conditions by
- 202 Milferstedt et al. (2013) [30].
- 203 The hydA gene present in *Clostridium Butyricum* strain DSM10702 was amplified with
- the following mix: 17.25 μ l molecular grade water, 2.5 μ l of 10 \times pfu turbo buffer, 2 μ l
- of 2.5 mM dNTP mixture, 1 μ l of forward primer (500 nM) F234
- 206 (ACCGGTGGAGTTATGGAAGC) and reverse primer (500 nM)
- 207 R273 (CATCCACCTGGGCATGCCAT), 0.25 µl of 2.5 U/µl Stratagene PfuTurbo
- 208 DNA Polymerase (Stratagene). The PCR conditions were : denaturation for 2 min at
- $94^{\circ}C$; 35 cycles of 3 steps, 30 sec at 94°C, 30 sec at 57°C and 30 sec at 72°C; a final
- elongation for 10 min at 72° C.

211	PCR products were analyzed by Capillary Electrophoresis – Single Strand
212	Conformation Polymorphism (CE-SSCP) in an ABI 3130 genetic analyzer (Applied
213	Biosystems) as described by (Rochex et al., 2008) [31], yielding a bacterial community
214	fingerprint. The obtained community profiles were aligned based on the ROX internal
215	size standards and normalized with the package Statfingerprints [32] in R 2.12 (R
216	Development Core Team, 2010).
217	Quantitative PCR samples were prepared on 96-well PCR plate (Eppendorf, Hamburg,
218	Germany) and analyzed with Mastercycler ep gradient S (Eppendorf, Hamburg,
219	Germany). The conditions for ARNr 16S were the same that Braun et al. 2011 [33]. For
220	hydA amplification by qPCR, the mix was composed of: 5.5 μ l of molecular grade
221	water, 12.5 µl of SsoAdvanced TM Universal SYBR® Green Supermix, 1 µl of primers
222	[250nM] F234 (ACCGGTGGAGTTATGGAAGC) and R233
223	(CATCCACCTGGGCATGCCAT), 5 μ l of DNA with two dilutions (1 and 0.1 ng). The
224	PCR cycle was composed of an enzyme activation step (2 min $98^{\circ C}$) followed by 40
225	cycles (15 sec $98^{\circ C}$ and 1 min $60^{\circ C}$) with monitoring of the melting curve.

227 3. Results and Discussion

228 3.1 Determination of VFA inhibition threshold value

Here, the objective was to determine the minimal VFAs concentration inhibitory for

230 hydrogen production. For that purpose, limitations by carbon source or mineral medium

231 were avoided all along the culture and the hydrogen partial pressure was kept constant

because reaction occurs at atmospheric pressure and the hydrogen concentration in

biogas was constant at 50%. The partial pressure was estimated at 0.565 bar by theDalton's law:

235
$$PH2 = Ptot * Yi (eq. 3)$$

where P_{H2} is the hydrogen partial pressure, P_{tot} the total pressure and Y_i the hydrogen mole fraction.

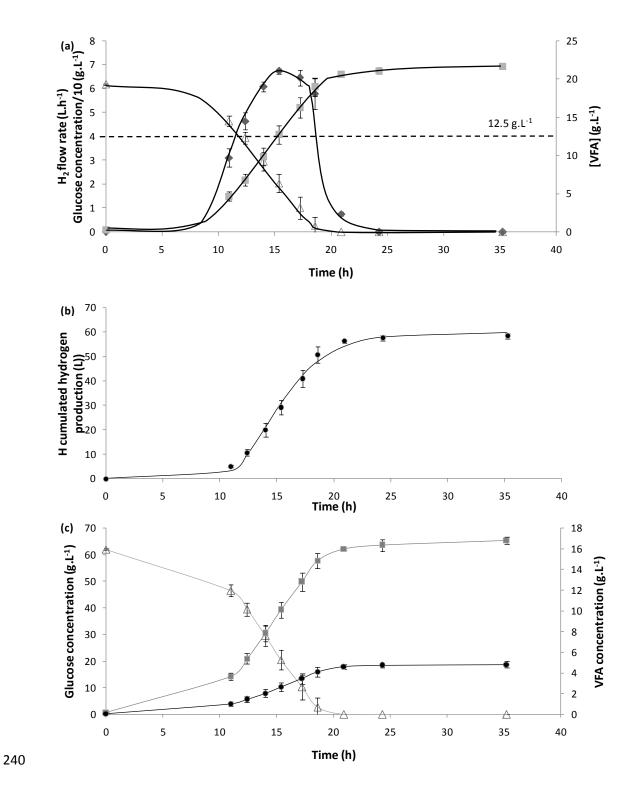


Figure 1: Results obtained in liquid and gaseous phase in control culture with the follow conditions: batch 5L, glucose concentration of 60 g.L⁻¹, 35°C, pH6 constant, 100 rpm with medium described in part 2.2. (a) Kinetic of hydrogen flow rate, glucose

- Figure 1 shows the kinetics of the hydrogen flow rate, the modeling of cumulative
- 239 hydrogen production and the VFAs production over time.

In Figure 1a, the hydrogen flow rate increased until a maximum of 7 L.h⁻¹ at 15 hours

and after a lag period of 10 hours. Then it slowly decreased between 15 and 20 hours

while glucose concentration was not yet limiting (20.48 g.L⁻¹ at 15 hours). No

improvement of hydrogen flow rate was observed by adding glucose at this time of the process indicating that glucose concentration was not limiting (data not shown). Only a gradual decrease of hydrogen flow rate was observed with initially VFAs addition in

257 figure 3b.

258 Finally, hydrogen production stopped after 24 hours, in response to glucose exhaustion.

259 Similarly to hydrogen flow rate, the VFAs production started after 10 hours and

increased until 20 hours to reach 20 $g.L^{-1}$. After this time, the VFA production also

slowed down due to glucose exhaustion.

Interestingly, when VFAs concentration reached 12.5 g.L⁻¹ with a B/A ratio of 3.8, the hydrogen flow rate started to decrease from 7 to 6 L.h⁻¹. Under the assumption of no limitation by mineral or carbon and a stable hydrogen partial pressure, such kinetic slowdown was most likely due to an excessive accumulation of volatile fatty acids.

266	In Figure 1b, the kinetic parameters were determined using the Gompertz model which
267	is the reference model used to characterize a biogas production. The experimental data
268	fitted well the model. The kinetic parameters were a lag phase of 11.21 hours, a
269	maximal hydrogen cumulated volume of 60 L and a maximal flow rate of 7.47 L.h ⁻¹ .
270	The global performance of this batch process was very interesting since the maximal
271	productivity (Hydrogen Production Rate) was one of the highest values found in the
272	literature $(1470 \pm 236 \text{ mL}_{\text{H2}}\text{.L}^{-1}\text{.h}^{-1})$. The obtained yield $(1.42 \text{ mol}_{\text{H2}}\text{.mol}_{\text{glucose}}^{-1})$ was
273	similar to others publications in mixed cultures and batch experiments with a yield
274	between 1-1.8 mol _{H2} .mol _{glucose} ⁻¹ [34,35].
275	The metabolite distributions are presented in figure 1c. The main metabolites were
276	butyrate and acetate. The final concentration of acetate and butyrate reached
277	respectively 4.81 and 16.81 g.L ⁻¹ for a B/A ratio of 3.5. Here, with the selected
278	microbial consortium and under these operating conditions, the butyrate pathway was
279	favoured with regard to the acetate pathway. Hydrogen production is generally
280	uncorrelated to the acetate pathway because of possible homoacetogenesis reactions, but
281	the butyrate pathway remains a good indicator [36]. With these concentrations, 2 mole
282	of hydrogen should be produced for one mole of cumulated acetate and butyrate. The
283	homoacetogenesis ratio of 0.86 indicates that only small quantity of butyrate and
284	hydrogen was converted into acetate. Other metabolites produced by competing
285	pathways of hydrogen production were detected in only very small quantity. The final
286	concentrations of propionate, lactate, ethanol and glycerol were respectively 0.06, 1.28,
287	0.76 and 1.46 g.L ^{-1} . These metabolites represented only 6.3% of the carbon consumed.

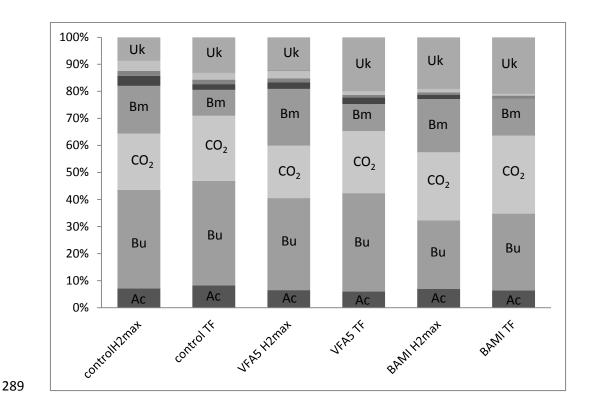
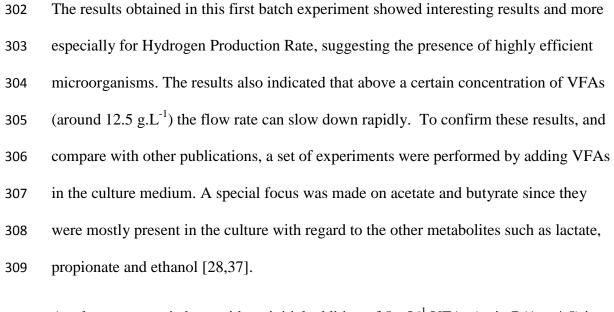


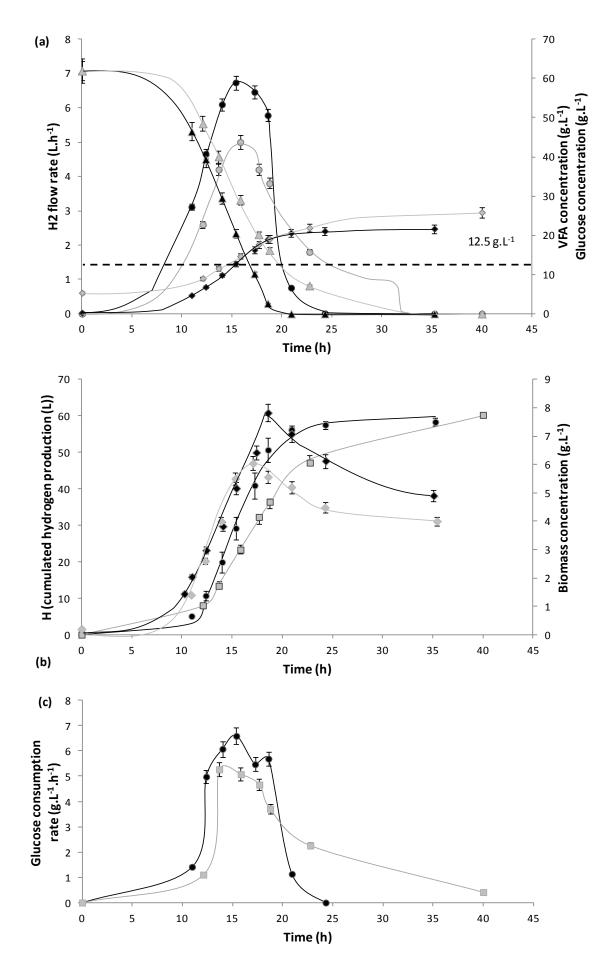
Figure 2: Carbon footprint of three cultures conditions: Control, VFA5 (Batch with 5 g.L⁻¹ of VFA adding in the culture medium initially), BAMI (culture in semi-continuous with submerged anaerobic bioreactor). The products were in ascending order: acetate, butyrate, CO₂, biomass, lactate, ethanol, glycerol, propionate and unknown metabolites. In this graphic, propionate was present in very small quantities in the three cultures, consequently it is not visible. The main metabolites were identified by abbreviation. Ac: acetate, Bu: butyrate, CO₂, Bm: biomass, Uk: unknow.

288	The global carbon recovery for this batch was 87% of total carbon (figure 2).

- 297 The toxicity of VFAs is clearly demonstrated in literature but the operating condition
- significantly differs. Several cultures were carried out with many initial VFAs
- 299 concentration and generally the cumulative hydrogen decreased from VFAs
- 300 concentration was closed to 5 g.L⁻¹.
- 301 3.2 Impact of VFAs addition on hydrogen production



- A culture was carried out with an initial addition of 5 g.L⁻¹ VFAs (ratio B/A = 4.5) in
- the initial culture medium and was compared with the control culture (no VFAs added).

312 The results of these two experiments are presented in Figure 3.

In the presence of initial VFAs, the lag phase was one hour longer compared to the 325 control. The toxicity of VFAs led to adjustment to the biomass before starting to 326 produce Hydrogen. A maximal flow rate of 5 L.h⁻¹ was observed after 15 hours in 327 presence of VFAs while a maximum of 7 L.h⁻¹ was reached in the control culture (figure 328 3a). The flow rate slowed down when the VFAs concentration reached 12.5 and 13.5 329 $g.L^{-1}$ and glucose exhaustion occurred at 20 and 32 hours in the control and the batch 330 with VFAs, respectively. Consequently, the average hydrogen production rate as 331 determined with the Gompertz model (figure 3b) was lower $(360 \text{mL}_{H2}.\text{L}_{\text{medium}}^{-1}.\text{h}^{-1})$ 332 with VFAs than in the control culture (524 mL_{H2} . L_{medium}^{-1} . h^{-1}). The main difference 333 334 between the two cultures was the glucose consumption rate (figure 3c). In the two cultures the glucose consumption rate increased until 6.6 and 5.3 $g_{glucose}$.L⁻¹.h⁻¹ in the 335 control and VFA5 cultures, respectively. When a VFAs concentration of 12.5 g.L⁻¹was 336 reached, glucose consumption rate decreased progressively until glucose exhaustion. 337

338	According to metabolite distribution (figure 2), no significant redirection of the
339	metabolic pathways was observed although the presence of an initial VFAs
340	concentration of 5g.L ⁻¹ but solvantogenesis reaction occurred at higher VFAs
341	concentration of 8 g.L ⁻¹ , and the hydrogen yield and productivity significantly decreased
342	(table 1). All these results suggest that the flow rate decrease in the VFA5 culture was
343	due to a slowing down of the metabolism flux (figure 3c) to resist to a high VFAs
344	concentration in the medium. During the culture with VFAs addition, the inhibitory
345	threshold was reached earlier, that's why less biomass was produced (figure 3b) and
346	consequently hydrogen productivity was reduced.

351	These results are similar to those obtained by Zheng and Yu, 2005 [38], who worked
352	with an initial butyrate concentration of 5 g.L ^{-1} (table 1), and observed that the
353	productivity decreased but the hydrogen production yield remained the same. Some
354	results from another experiment performed in the laboratory showed that yield and
355	productivity decline when VFAs concentration is higher than 5 $g.L^{-1}$ similarly to Y.
356	Wang et al., 2008 [40]; Zhang et al., 2012 [39] results. During this experiment (table 1),
357	solventogenesis reaction produced lactate in largest quantity and consequently the
358	hydrogen yield decreased. Butyrate has a negative effect on hydrogen production
359	comparable to acetate, with a higher toxicity on bacterial cells [39,41].
360	3.3 Sequential continuous operation with submerged anaerobic membrane
361	bioreactor
362	Previous results show that VFAs accumulation was harmful to hydrogen production,
363	and the toxicity threshold value was estimated at 12.5g/L. In order to maintain a VFAs
364	concentration below this toxicity level, the use of a membrane was evaluated, which
365	may allow the extraction of the culture medium containing VFAs while recycling the
366	microbial biomass. At the same time, the reactor volume can be kept constant by
367	addition of culture medium and dilution of residual VFAs.
368	The results obtained with the submerged anaerobic membrane bioreactor were
369	compared to the control culture in batch.
370	3.3.1 Hydrogen production versus Volatile fatty acids accumulation
371	Cumulated hydrogen production, H ₂ flow rate, VFAs production and glucose

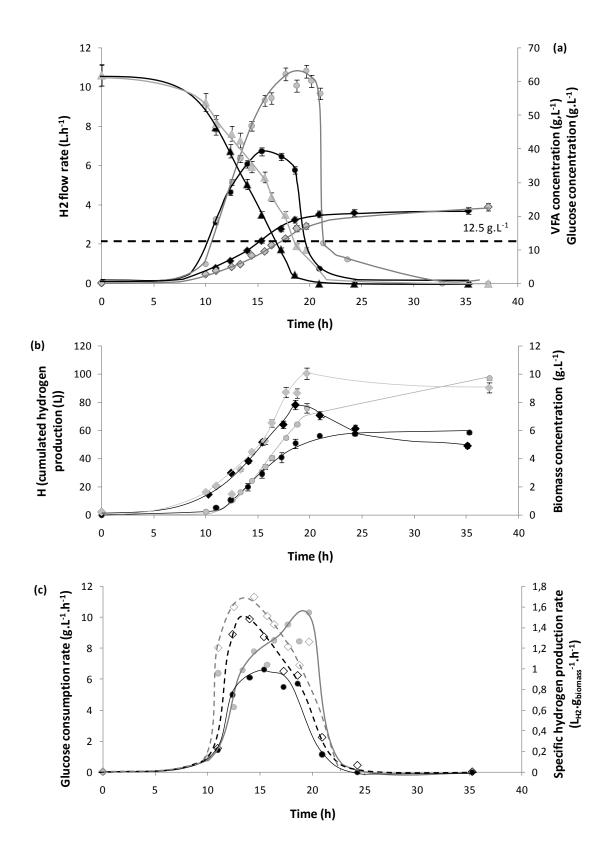


Figure 4: comparison of control culture and BAMI culture in submerged membraneanaerobic bioreactor. During BAMI culture, five withdrawal of one liter medium was

372	consumption rate as well as specific hydrogen production rate are presented in figure 4.

The Hydrogen flow rate was similar to the control during the ten first hours of culture. 387 A significant difference was observed from the time when VFAs began to be extracted 388 thanks to the membrane technology. The reduction of fermentative co-product 389 accumulation in the medium induced an increase of the maximum H₂ flow rate. This 390 latter reached 10 L.h⁻¹ at 17 hours of culture compared to 7 L.h⁻¹ in the control (figure 391 4a). This value was maintained close to 10 L.h⁻¹ during 4 hours and then dropped after 392 21 hours of culture because of glucose exhaustion. This maximal flow rate was same 393 that the value determined by Gompertz model in the figure 4b (9.99 L.h⁻¹). Stopping the 394 increased Hydrogen flow rate could be correlated to a VFAs concentration close to 395 13g.L⁻¹. This value was very close to the toxicity threshold determined for the control 396 culture in our previous experiment. Therefore, the use of a submerged membrane 397 significantly improved the average performance of the anaerobic process (table 1). The 398 average and maximal hydrogen production rates reached 0.75 and 2.47 L_{H2}.L⁻¹.h⁻¹ 399

400	against 0.52 and 1.64 in the control respectively because more biomass was produced
401	(figure 4b) thanks to VFAs extraction which delays the attainment/ reaching of the
402	inhibitory threshold. The hydrogen yield $(1.58 \text{ mol}_{H2}.\text{mol}_{glucose}^{-1})$ was also high when
403	compared to the control (1.42 $mol_{H2}.mol_{glucose}^{-1}$). The obtained yield was higher than
404	Lee et al. (2008) [42] with 1.27 mol _{H2} .mol _{glucose} ⁻¹ . No recent publication investigated
405	hydrogen production with anaerobic membrane bioreactor performing in semi-
406	continuous mode as this study, but the maximum hydrogen production rate (2.47 L_{H2} .L ⁻
407	¹ .h ⁻¹) was greater than others process operated in continuous mode as Lee et al. (2008)
408	$(1.48 L_{H2}.L^{-1}.h^{-1})$ [42] and Oh et al. (2004) (0.64 $L_{H2}.L^{-1}.h^{-1})$ [43]. It can suppose that the
409	performance will be close in continuous mode. The membrane technology applied in
410	these experiments offered great performance in comparison with others technology used
411	to concentrate biomass and improve hydrogen production. For example, Ishikawa et al.,
412	2008 [44] developed a compact stacked flatbed reactor performed in continuous mode
413	and obtained 1.2 mol _{H2} .mol _{glucose} ⁻¹ and 0.8 L_{H2} .L ⁻¹ .h ⁻¹).

414 The produced metabolites were similar (figure 2). The B/A ratio was slightly lower (3.3) than in the control (3.7) and no homoacetogenesis reactions was observed (ratio 415 homoacetogenesis reaction was 0.99). These results can explain the higher hydrogen 416 yield because in the acetate pathway, 4 moles of hydrogen are produced from one mole 417 418 of glucose versus only two in the butyrate pathway. The other metabolites produced by 419 concurrent hydrogen pathway represented only 4% of the total available carbon (figure 420 2). The other metabolites yields were lower than in the control. The global carbon recovery at end of the BAMI culture (Anaerobic Immerged Membrane Bioreactor) was 421 422 80% but a part of biomass was not considered because it clogged at the surface of fibers 423 membrane.

424	These experiences confirmed the influence of metabolic co-products on hydrogen
425	production, with a inhibitory concentration close to 13 g.L ⁻¹ . The use of a submerged
426	membrane in the anaerobic bioreactor has delayed the accumulation of this inhibitor in
427	the medium consequently; more biomass was produced, which increases the rate of
428	hydrogen production even if the yield of hydrogen produced remains very close. It also
429	allowed obtaining a solution of fatty acids, without microorganisms, which could be
430	directly used for green chemistry or for the coupling of other processes as
431	photofermentation or yeast culture for single one oil production [11].
432	3.3.2 Study of consortium by SSCP and quantitative PCR analysis
433	To achieve a better understanding of the microbial dynamics during the culture,
434	molecular and quantitative analyzes were performed from the solid phase. SSCP
435	profiles using the V3 region of RNA 16S specific primers were used as fingerprint

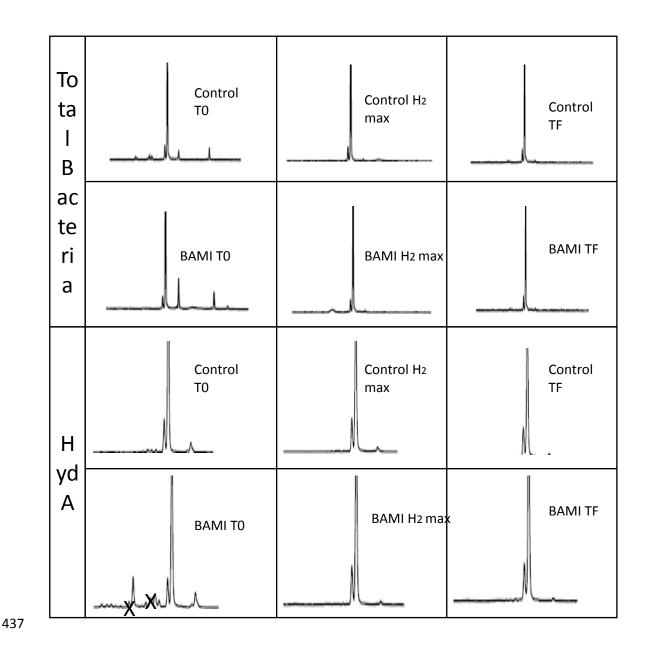


Figure 5: Qualitative and quantitative analyzes of microorganisms realized on samples

436	analysis to provide information on biodiversity present in the culture (figure 5).

The chromatograms obtained for total bacteria from BAMI and control cultures werevery close at the beginning of the culture suggesting that the initial conditions were

445 similar regarding the microbial community. A low diversity was observed in these samples with mainly one major bacterium and only few other bacteria. During culture at 446 447 maximal H₂ production and at the end of batch, the minor bacteria were still present but 448 in very small proportions compared to the dominant species. Hydrogen producer biodiversity was also analysed thanks to SSCP profiles targeting the hydA gene. The 449 450 SSCP profiles presented low diversity as for total bacteria. Several bacteria were found but only one was predominantly present in the sample. By cross-checking with RNA 451 452 16S profiles, it appears that the main dominant species carried also the hydA gene. Strict 453 anaerobic fermentative bacteria such as *Clostridium* sp. are well known to carry this gene for hydrogen production [45]. This was confirmed by the sequencing results, 454 455 where the most abundant species was related to *Clostridium* sp. (94 - 99% in BAMI culture and control culture). The most abundant was *Clostridium butyricum strain CDC*-456 457 51208. At the end of the culture, the same bacteria were found but the difference in concentration between other species was significant both in the BAMI and the control 458 culture. According to the qPCR study, the difference between the total population and 459 460 the H₂-producing population remained constant regardless of the conditions tested. Only an increase in the bacterial population was logically observed when membrane was 461 462 used. During these cultures, no sub-dominant bacteria emerged, and the consortium 463 remained stable, meaning that the initial presence of VFAs did not influence the microbial community structure, but only affected the metabolic pathways. VFAs 464 465 accumulation increased the osmotic pressure; when it became too large a progressive 466 lysis of microorganisms is observed and hydrogen production can slow down [20]. This 467 phenomenon occurred here when the concentration of volatile fatty acids is higher than 12.5 g.L⁻¹. In BAMI culture, the specific hydrogen production rate was slightly higher 468

than in the control (15%) but this difference was not significant because a part of
biomass stayed on fibers membrane. The specific hydrogen production rate was closed
in the two cultures and the increased hydrogen productivity in BAMI culture was due to
the biomass recycling which promoted biomass production that's why the glucose
consumption rate was higher in BAMI culture. The use of membrane technology did not
cause metabolic perturbation (figure 2) but favored biomass production and
consequently improved hydrogen production.

477 4. Conclusion

With the bacterial consortium used in this study, the toxicity threshold of VFAs was 478 determined. A decrease of the hydrogen production rate was observed when the 479 concentration of hydrogen fermentation co-products reached 12.5 g.L⁻¹. It was 480 481 demonstrated that using Anaerobic Membrane Bioreactors (AnMBR) represent an interesting technology to limit the accumulation of VFAs while maintaining the biomass 482 in the medium. In response, maximal hydrogen production rate was increased of 51% 483 with respectively 1.64 and 2.47 L_{H2} . L_{medium}^{-1} . h^{-1} for BAMI culture and control culture. 484 Even if clogging represents a risk with this technology and can lead to technical 485 difficulties, the improvement in hydrogen production remains significant. The challenge 486 now is to see how the system behaves during a longer operating time by increasing the 487 withdrawal flow rate and limiting the accumulation of VFAs. The valorization of the 488 permeate enriched in VFAs in an associated process represent also an interesting 489 490 perspective of this work.
