# Number of zeros of exponential polynomials in zero residue characteristic

#### Abstract

Let $\mathbb{L}$ be a complete ultrametric field of residue characteristic 0 and let $F(x)=\sum_{i=1}^{k} f_{i}(x) \exp \left(\omega_{i} x\right)$, with $\omega_{i} \in \mathbb{L},\left|\omega_{i}\right|<1$. The number of zeros of $F$ in the unit disk is bounded by $n-1$.


Notations: We denote by $\mathbb{L}$ a complete field wit respect to an ultrametric absolute value, with residue characteristic 0 and we denote by $v$ the valuation linked to $\mathbb{L}$ as $v(x)=-\log (|x|)[1]$. Next, we denote by $\mathbb{K}$ an algebraically closed field $\mathbb{K}$ complete with respect to an ultrametric absolute value with zero residue characteristic. Given $r>0$, we denote by $d_{\mathbb{L}}(0, r)$ the disk $\{x \in \mathbb{L}||x| \leq r\}$ and by $d_{\mathbb{K}}(0, r)$ the disk $\{x \in \mathbb{K}||x| \leq r\}$.

In an algebraically closed field $\mathbb{K}$ complete with respect to an ultrametric absolute value with residue characteristic $p>0$, the number of zeros of a sum of exponential polynomials was examined in several papers. Following [6] and [8], the best estimation was given in [7] and this was also given in [4]. Here we will follow the method of [6] in order to examine a similar problem on the field $\mathbb{L}$ which might apply to fields such as Levi-Civita fields [5].

Given $r>0$, we denote by by $H(d(0, r))$ the $\mathbb{K}$-algebra of anaytic elements in $d_{\mathbb{K}}(0, r)$, i.e. the set of power series $\sum_{j=0}^{\infty} \lambda_{j} x^{j}$ converging in $d_{\mathbb{K}}(0, r)[3]$.

The radius of convergence of the exponential function $\exp (x)=\sum_{j=0}^{\infty} \frac{x^{j}}{j!}$ is 1 in the field $\mathbb{K}$ and the fuction converges in all $d_{\mathbb{K}}(0,1)$ [1], [2].

Theorem M: Let $\mathbb{L}$ be an ultrametric complete field of residue characteristic 0 and let $F(x)=\sum_{i=1}^{k} f_{i}(x) \exp \left(\omega_{i} x\right)$ where each $\omega_{i} \in \mathbb{L}$ satisfies $v\left(\omega_{i}\right)>0$, each $f_{i}$ lies in $\mathbb{L}[x]$ and $\operatorname{deg}\left(f_{i}\right)=m_{i}-1$. Let $n=\sum_{i=1}^{k} m_{i}$.

Then the number $N$ of zeros of $F$ in the disk $d_{\mathbb{L}}(0,1)$, taking multiplicity into account, satisfies $N \leq n-1$.

Before proving Theorem M, we have to recall the following Theorem A that is Theorem B.13.7 in [2] together with some notations and classical properties:

Notation: Let $r>0$ and let $f(x)=\sum_{j=0}^{\infty} a_{j} x^{j} \in H\left(d_{\mathbb{K}}(0, r)\right)$ [3]. Then $\lim _{j \rightarrow+\infty}\left|a_{j}\right| r^{j}=0$ and we denote by $\nu^{+}(r, f)$ the unique integer $t$ such that $\left|a_{t}\right| r^{t}=\sup _{j \in \mathbb{N}}\left|a_{j}\right| r^{j}>\left|a_{j}\right| r^{j} \forall j>t$ [1], [2].

Theorem A: Let $r>0$ and let $f \in H\left(d_{\mathbb{K}}(0, r)\right)$. The number of zeros of $f$ in $d_{\mathbb{K}}(0, r)$ is equal to $\nu^{+}(f, \log r)$, (taking multiplicity into account).

Proof of Theorem M: Let us first suppose that the field $\mathbb{L}$ is algebraically closed and hence is $\mathbb{K}$. Denoting by $D$ the derivation $\frac{d}{d x}$, then $F$ satisfies a relation of the form

$$
\begin{equation*}
D^{n} F=c_{1} D^{n-1} F+c_{2} D^{n-2} F+\ldots+c_{n} F \tag{1}
\end{equation*}
$$

where

$$
\begin{equation*}
\prod_{i=1}^{k}\left(x-\omega_{i}\right)^{m_{i}}=x^{n}-c_{1} x^{n-1}-c_{2} x^{n-2}-\ldots-c_{n} \tag{2}
\end{equation*}
$$

Expanding $F$ as a power series, we have

$$
F(x)=\sum_{h=0}^{\infty} a_{h} x^{h}=\sum_{h=0}^{\infty} \frac{b_{h}}{h!} x^{h},|x|<1 .
$$

From the differential equation (1), we have the recurrence

$$
\begin{equation*}
b_{h+n}=c_{1} b_{h+n-1}+\ldots+c_{n} b_{h}, h=0,1,2, \ldots \tag{3}
\end{equation*}
$$

Let $\epsilon=\min _{1 \leq i \leq n} v\left(\omega_{i}\right)$. Since the radius of convergence of the exponential $\exp (x)$ is 1 in a field of residue characteristic 0 [1], [2], the series $F$ converges in $d_{\mathbb{K}}(0,1)$, hence it lies in $H\left(d_{\mathbb{K}}(0,1)\right)$, and therefore we can put $t=\nu^{+}(F, 1)$. Without loss of generality, we can suppose that $\left|a_{t}\right|=1$. Thus we have $\left|a_{t}\right|=1$ and $\left|a_{h}\right|<1 \forall h>t$. Consequently by Theorem M the number of zeros of $F$ in $d_{\mathbb{K}}(0,1)$ is $t$. From (2), we can see that $v\left(c_{j}\right) \geq j \epsilon(j=1,2, \ldots, n)$.

Now, by assumption we have $v\left(a_{h}\right) \geq 0$ and $v\left(a_{h}\right)=v\left(b_{h}\right)-v(h!)=v\left(b_{h}\right)$ because $v(h!)=0 \forall h$, hence $v\left(b_{h}\right) \geq 0(h=0,1, \ldots)$. By (3), we have

$$
v\left(b_{n}\right) \geq \min _{1 \leq j \leq n}\left(v\left(c_{j}\right)+v\left(b_{n-j}\right)\right)>\min _{1 \leq j \leq n}\left(\epsilon j+v\left(b_{n-j}\right)\right) \geq \epsilon
$$

Then, by (3) with $h=1,2, \ldots$ we have $v\left(b_{h+n-1}\right)>h \epsilon$, hence

$$
v\left(a_{h+n-1}\right)>h \epsilon-v((n-1+h)!)=h \epsilon \forall h \geq 1 .
$$

Thus for every $h \geq 1$, we have $v\left(a_{h+n-1}\right)>0$, hence $t \leq n-1$. Consequently, the number of zeros of $F$ in $d(0,1)$ is bounded by $(n-1)$, which ends the proof when the field $\mathbb{L}$ is algebraically closed.

Consider now the general case, when $\mathbb{L}$ is not supposed to be algebraically closed. The field $\mathbb{L}$ then admits a unique algebraically closed extension complete with respect to an ultrametric absolute value that continues this of $\mathbb{L}$ (see for example Theorem A.5.14 !n [2]). Then $F(x)$ has continuation in the disk $d_{\mathbb{K}}(0,1)$ and has at most $n-1$ zeros in $d_{\mathbb{K}}(0,1)$ taking multiplicity into account, hence of course it has at most $n-1$ zeros in the disk $d_{\mathbb{L}}(0,1)$ taking multiplicity into account.
