# Abstract:

This article describes several extraction chromatographic materials aiming to offer improved potential for isolating trace elements with high charge/ionic radius ratio from accompanying matrix elements in natural samples. Starting from the commercially available, field proven, TRU- and RE-Spec materials (Eichrom Technologies), three resins containing less TBP in the CMPO-TBP mixtures, or even neat CMPO only, have been prepared and characterized through measurement of the distribution ratios of some fifty elements in HNO3 and HCl media of variable strength. These resins were further evaluated for analytical applications on geochemical samples. The results highlight a strong enhancement of weight distribution ratios of many elements of interest in geochemistry, cosmochemistry and environmental sciences (Lanthanides, naturally occurring Actinides, High Field Strength Elements). Combined with good chromatographic characteristics, these high Dw's make it possible to achieve excellent group separations by using very small columns operated at high, gravity driven flow rate. Moreover, in an attempt to further improve the selectivity against Fe(III) and Ti(IV), preliminary investigations were made on an additional pair of resins impregnated with a CMPO-substituted calixarene. Although promising distribution ratio data were obtained, these prototypes did not permit to prepare columns with satisfactory chromatographic characteristics, and this approach still waits for a better impregnation method of the porous inert support.

# 44 INTRODUCTION

Because it combines the versatility and selectivity of solvent extraction with the ease of operation and multi-stage characteristics of chromatographic columns, extraction chromatography (EXC) provides a powerful approach to separation chemistry at the analytical scale. [1] In the 1990's, a suite of specific EXC materials was developed by E.P. Horwitz and his group at Argonne [2] and made available on a commercial basis. [3, 4] These ready-to-use resins allowed great improvements, both in terms of miniaturization and selectivity, of the separation protocols of many trace elements important in Earth, environmental, and planetary sciences. [5] The first of these EXC materials was developed in order to quantitatively isolate the actinides as a group from urine samples before measurements by  $\alpha$ -spectrometry. It was based on a mixture of CMPO dissolved in TBP and sorbed on to a porous, polyacrylic ester inert substrate (Amberlite XAD-7). [6] This EXC resin was further improved by using another support with smaller particle size (50-100 µm) and larger average pore diameter (Amberchrom CG71), and marketed as TRU Spec (for TRans Uranic Specific) resin. [7] The new method was derived from the liquid-liquid extraction process referred to as TRUEX, [8, 9] based on the neutral organophosphorus extractant octyl(phenyl)-N, N-diisobutylcarbamoylmethylphosphine oxide (CMPO) [10] dissolved in a solvent composed of tri-n-butyl phosphate (TBP) and aliphatic hydrocarbon diluent. This mixture allowed the extraction/recovery of all actinides from acidic nuclear wastes solutions. Likewise, the TRU Spec resin provides an efficient means to achieve the isolation of U and Th from complex matrices such as geological samples dissolved in nitric acid media. [11] Most interestingly for geochemists, by virtue of the chemical similarity of the light Rare Earths (LREE) with Am(III), one of the main targets of TRU Spec, this resin also proved to permit their easy separation from most elements but Fe(III) and Ti(IV). [12, 13] A closely related resin, referred to as RE Spec (for Rare Earth Specific), differing from TRU Spec by a slightly higher proportion of CMPO in the extractant mixture, was also released by Eichrom. In their most useful work, Huff & Huff determined with ICP-Atomic Emission Spectrometry the distribution coefficients of both resins for 42 and 32 elements in nitric and hydrochloric acid media, respectively. [14] However, even the RE Spec resin suffers from a rather low affinity for the heaviest lanthanides (e.g.,  $D_w$ 's = 10-30 for Lu [15]) in the range of nitric acid (1-3M) convenient to handle geological sample solutions, and permitting to use ascorbic acid as a masking agent for Fe(III) through reduction to Fe(II). This is a serious shortcoming limiting the practical use of RE Spec in miniaturized separation schemes aiming to quantitatively recover the whole Lanthanide series by using very small columns. A comparison of the distribution data available for both TRU- and RE Spec [14] reveals a significant increase of the D's of elements of interest, including the HREE, from TRU Spec (13 wt% CMPO-27% wt% TBP) to RE Spec (16% wt% CMPO-24% wt% TBP). This observation suggests that CMPO plays the major active role in the blend of extracting agents, in line with the fact that CMPO was the key ingredient in the original liquid-liquid extraction process [6]. Indeed, in the TRUEX process, TBP was mainly used as a phase modifier in order to increase the metal ion loading capacity and extractant compatibility with alicyclic and aliphatic diluents and prevent the formation of a second organic phase. [16] Such problems should not be a source of concern in EXC of trace elements, and it was anticipated that EXC resins containing less TBP in the CMPO-TBP mixtures, or even prepared from neat CMPO, might offer improved distribution ratios for the HREE and the rest of the elements of interest. On this basis, three new resins have been prepared and characterized for the distribution ratios of some fifty elements in HNO<sub>3</sub> and HCl media. Two of these resins were further evaluated for potential analytical applications. Moreover, in an attempt to improve the selectivity against Fe(III) and Ti(IV), exploratory investigations were made on an additional pair of resins impregnated with a more complex molecule, specifically a CMPO-substituted calixarene belonging to a new class of highly efficient extractants for lanthanides and actinides developed in the late 1990's. # **Preparation of EXC materials**

In every case, the polyacrylic ester resin Amberchrom CG-71 (50-100 µm particle size) was used as the porous inert support. A 40 wt% loading of this support corresponds to complete filling of the pores [20] and this total impregnation was chosen in every case, in line with all other previous EXC resins prepared by using the same porous support. Variable proportions of the conventional CMPO and TBP extracting agents were used to prepare three new EXC materials, hereafter referred to as P-1 (20 wt% CMPO-20 wt% TBP), P-2 (35 wt% CMPO-5 wt% TBP), and P-3 (40 wt% CMPO). These were prepared on demand at Triskem International (Bruz, France), following a procedure similar to that outlined by Horwitz et al. [6] A summary of the CMPO/TBP ratio of these prototypes against the commercially available materials TRU and RE is given in Table 1. On an exploratory basis, an additional pair of resins were prepared with a third ligand, herafter referred to as «Calix-CMPO», consisting in a calix[4]arene bearing four CMPO-like functional groups attached on the wider rim. This compound was chosen on the basis of earlier solvent extraction studies showing a largely enhanced affinity for tri- and tetravalent actinides compared with CMPO, [17] along with strong size selectivity among the lanthanide series. [18, 19] The molecule (mass 1756; J.F. Dozol, pers. comm.), not available commercially, was synthesized on demand by, and purchased from Marshallton Research Laboratories Inc. (King, NC, USA). Two prototypes, hereafter referred to as PC-1 and PC-2, were prepared at Triskem. The first one was impregnated with 7.5 wt% Calix-CMPO dissolved in chloroform, while the second contained, in addition to 7.5% Calix-CMPO in chloroform, 2.5 wt% octanol (A. Bombard, pers. com.). Unlike the CMPO +/- TBP-based resins, PC-1 and PC-2 did not behave

as free flowing powders, possibly reflecting the presence of excess ligand at the surface of the resin beads, as also could be inferred from the difficult wetting of both resins. In spite of this obvious shortcoming, these prototypes were used for distribution ratios measurements, in order to evaluate the potential of the novel molecule in terms of selectivity against major elements. The results of these preliminary investigations are given in Appendix A1.

### Measurements of weight distribution ratios

# Reagents

Solutions of mineral acids (HNO<sub>3</sub>, HCl, HF) were prepared from reagent grade acids (Fluka) purified by subboiling distillation in PFA Teflon DST-100 systems (Savillex, Eden Prairie, MN, USA) and diluted with 18.2 MOhm cm water obtained from a deionization device (Aqua System Distribution, Bondoufle, France). Ascorbic acid (Aldrich), chosen as a reducing agent, was used as received.

Metal ion solutions used for the determination of distribution ratios were prepared from a set of five, separate, multi-element standard solutions traceable to NIST (Inorganic Ventures, Christiansburg, VA, USA) containing 10 µg mL<sup>-1</sup> of (1) the 14 lanthanides, Sc, Y, Th, and U in 5% v/v nitric acid; (2) Au, Ir, Pd, Pt, Re, Rh, Ru, and Te in 10% v/v HCl; (3) Ge, Mo, Nb, Hf, Ta, Ti, Sn, W, and Zr in 5% v/v in 5% v/v nitric acid containing traces of hydrofluoric acid for stability; (4) As, B, Ba, Be, Bi, Cd, Ga, In, Pb, Sb, Se, Tl, and V in 5% v/v nitric acid; (5) Ag, Al, Ca, Cs, Co, Cr, Cu, Fe, Li, Mg, Mn, Na, Ni, K, Rb, Sr, and Zn in 5% v/v nitric acid.

### **Batch uptake of metal ions**

In order to investigate the acid dependence of the uptake by the resins of metal ions from both HNO<sub>3</sub> and/or HCl media, weight distribution ratios (D<sub>w</sub>'s) were determined by using the batch extraction method. An amount of resin in the 10-50 mg range was precisely weighed (W<sub>res</sub>) in a polypropylene micro tube (Eppendorf) and contacted with a precise weight (1-2 g) of acid solution (W<sub>liq</sub>) of variable strength containing the elements of interest at the 10 ng g<sup>-1</sup> level. The ratio of resin to solution was intentionally varied in order to produce, as far as possible, a significant difference between the initial and final concentrations. Then, the micro tubes were placed in a 3D rotary mixer at room temperature (20 +/- 0.5°C) in order to intermingle the solid and liquid phases. After 1 hour contacting time, the resin was separated by centrifugation for 10 minutes at 12 000 rpm. In >/ 5M acids, however, the resins floated at the surface of the denser acid, and the liquid phase was separated by filtration through a 0.45 um porosity PTFE membrane within a polypropylene housing (Puradisc 25 TF, Whatman) fitted on a syringe. Finally, a weighed aliquot of the supernatant or filtered solution was taken, precisely diluted by weight to ~ 4 mL, and analysed by ICP-MS with a quadrupole instrument (Agilent 7500 Ce). Aliquots of the initial solutions were processed in the same manner to determine their concentration before equilibration with the resin. In order to overcome isobaric interferences by polyatomic ions, low mass elements (<80) were measured as often as possible by using the collision cell filled with He gas. Based on these ICP-MS data, the mass initially contacted with the resin  $M_0$  and the mass left behind in the liquid phase  $M_{liq}$  were found for each element. The mass of element extracted by the resin was obtained by difference Mextr=M<sub>0</sub> - M<sub>liq</sub>, and the weight distribution ratio was calculated as the ratio of the concentration of element in the resin to the concentration of element left in the solution after equilibration.

Based on duplicate measurements in 0.5M HNO<sub>3</sub>, the precision of distribution ratios is, in general, about 10% or better for most elements, but can be markedly worse when the concentration difference between the initial and equilibrated solutions was difficult to quantify (corresponding to very low  $D_w$ 's) and when the amount of elements left in the equilibrated solution was very small (corresponding to very high  $D_w$ 's). However, from a practical point of view, a precise determination of both very low and very high  $D_w$ 's is generally not required to set up separation schemes.

# **Metal ion capacity**

The capacity of P-2 and P-3 resins was determined by measuring the volume of a solution of Pr (1 mg mL<sup>-1</sup> in 1M HNO<sub>3</sub>) needed to saturate a slurry-packed column of each resin, on the one hand, and by measuring the amount of Pr stripped from the column with 0.05M HNO<sub>3</sub> and 1M HCl, after having washed out the volume of Pr interstitial solution, on the other. These two determinations differed by less than 5%, and their average was reported.

## **Kinetics of uptake**

The uptake kinetics for Pr on P-2 and P-3 resins was studied by equilibrating, in a series of centrifuge tubes, 20 mg of each resin with 1.8 mL of a 100 ng mL<sup>-1</sup> solution in 1M HNO<sub>3</sub>, at 20°C. At various shaking time intervals, the solution was promptly separated from the resin by centrifugation at 12 000 rpm. A 0.5 mL aliquot was carefully withdrawn from the tube with a pipette, and the amount of Pr left in the aqueous phase measured by ICP-MS. The percentage of Pr extracted was calculated by difference from the nominal amount (180 ng) contacted with the resin.

# **Column parameters**

The resin bed density was determined by measuring the volume occupied by 1.00 g of dry P-2 and P-3 resins slurry-packed in a calibrated cylinder. The volume of stationary phase, Vs, was calculated from the nominal wt% of extracting agent sorbed onto the inert support and the extractant density, not different within uncertainty from 0.98 g mL<sup>-1</sup> for both TBP <sup>[21]</sup> and CMPO. <sup>[22]</sup> The volume of mobile phase, Vm, also referred to as the free column volume (FCV) was determined by measuring the volume of 1M HNO<sub>3</sub> preceding the breakthrough of Cs, an element not extracted by the resins.

# **RESULTS AND DISCUSSION**

As a first step of this work, the trend of increasing D<sub>w</sub>'s for tri-and tetra-valent elements as a function of CMPO loading, noticed from the data <sup>[14]</sup> published for the commercially available TRU (13 wt% CMPO-27 wt% TBP) and RE (16 wt% CMPO-24 wt% TBP) resins was investigated. For this purpose, a first prototype of resin was prepared featuring a further small increment of CMPO in the mixture of extracting agents, that is, 20 wt% CMPO-20 wt% TBP. This EXC material, hereafter referred to as P-1, was used for the determination of weight distribution ratios in nitric acid media of increasing molarity. The results are compared with those available <sup>[14, 15]</sup> for the Lanthanide series on the TRU and RE resins in 1M HNO<sub>3</sub> (Fig. 1). Overall, the data confirm that increasing the proportion of CMPO in the CMPO-TBP mixture enhances the extraction of all lanthanides, with a broadly homogeneous, twofold increase of D<sub>w</sub>'s for the light and medium REE (from La to Dy) on the P-1 resin compared to RE Spec, but

this enhancement is less pronounced for the heavy REE (from 1.7 for Ho to 1.25 for Lu, respectively).

Based on these observations, two further resins were prepared with a strongly reduced amount of TBP (P-2, 35 wt% CMPO-5 wt% TBP) and no TBP at all (P-3, 40 wt% neat CMPO), respectively. These two resins were further investigated in detail for their distribution ratios, capacity, and uptake kinetics. Their main characteristics are given in Table 1 of Appendix A2 (as supplemental material). Not unexpectedly, most of these data do not differ within uncertainty from those given for the original TRU resin <sup>[7]</sup>, based on the same porous inert support and a mixture of the same ligands.

The results of the uptake kinetics experiments are displayed in Fig. 2. It can be seen that >90% of uptake is achieved in 5 minutes by both resins. This is in line with previous data reported for three other EXC materials using the same support Amberchrom CG71.<sup>[20]</sup> It has been reported that the time required to reach equilibrium was somewhat longer for a « solvent free » Sr EXC resin than for the conventional, octanol-bearing resin.<sup>[23]</sup> It is therefore noteworthy that the extraction by P-3, prepared with neat CMPO (solid at room temperature), proceeds as rapidly as for the resins containing variable amounts of TBP (liquid at room temperature) as a diluent (TRU: 27 wt%, P-2: 5 wt%).

# Acid dependence of distribution ratios in nitric and hydrochloric acids

The weight distribution ratios measured for a range of elements on P-1, P-2 and P-3 as a function of increasing concentration of nitric and hydrochloric acids are listed in Tables 2 to 8 of Appendix A2 (as supplemental material). It turns out that the affinity scale is qualitatively similar in both acids. That is, all metal ions not extracted from HNO<sub>3</sub> at any concentration also do not display any uptake in the 0.05M-6M HCl range and, conversely, those elements

extractable from nitric acid media show significant, albeit variable, uptake. Also, P-3 consistently achieves higher  $D_w$ 's than P-2, confirming that CMPO, rather than TBP, is the major extractant involved in the uptake of most elements, irrespective of the acid medium.

# Behavior of common elements, particularly iron

Many elements do not display any significant extraction by the CMPO-based resins, from both nitric and hydrochloric media, at any acid strength. These include all the alkali and alkaline earth metals, many transition metals (Mn, Co, Ni, Cu, Zn) and groups 13 (B, Al, Ga, In, Tl) and 14 (Si, Ge, Sn, Pb) elements. In the divalent state, Fe is not extracted from both acids. In contrast, its uptake as Fe(III) is quite significant and increases markedly with increasing concentration of HNO<sub>3</sub>; this effect is even more pronounced for the undiluted CMPO (P-3) resin, thereby confirming the relatively poor selectivity of CMPO with regard to this major element in its trivalent state (Fig. 3). In HCl, however, the uptake of Fe(III) is different (Fig. 3), as shown by its higher extraction by the P-1 resin (20 wt% TBP-20 wt% CMPO) suggesting that, in this medium, its uptake is preferentially caused by the TBP component. This inference is broadly consistent with very large distribution ratios reported in the 100% TBP-HCl solvent extraction system. [24]

#### *Group 4, 5 and 6 elements*

Above 0.5M HNO<sub>3</sub>, the uptake of Group 4 elements (Ti, Zr, Hf) is important and increases as a function of nitric acid strength, with a strong preference of both resins for Zr (Fig. 4). Albeit their hydrolysis propensy at relatively low acid strength makes the data less robust, Group 5 and 6 elements (Nb, Ta, Mo, W) follow a similar trend (Fig. 4). The P-3 resin shows a stronger

affinity than P-2 for Zr and Hf, but the reverse is true for Nb and Ta, while the two resins do not differ appreciably for Mo and W. High  $D_w$ 's are also achieved in >1M HCl for all these elements (Fig. 5), hereafter collectively referred to as High Field Strength Elements (HFSE). This observation is in agreement with earlier data documenting largely enhanced extraction of these elements by the RE resin in even more concentrated (i.e., 8M) HCl. [14] Further, the HFSE display two different kinds of acid dependence (Fig. 5). Indeed, while Zr, Hf, and Mo are characterized by a sharp increase of their  $D_w$ 's from very low values to several hundred when the HCl concentration rises from 0.05 to 1 M, W, Nb, and particularly Ta, display very high  $D_w$ 's whatever the HCl molarity.

#### Lanthanides and natural actinides

In nitric acid, the Actinides (Th, U), light Lanthanides (from La to Eu), and Sc are all very strongly extracted, with extremely high Dw's (> 1000) achieved for both resins, even at moderate acid strength. Again, the resin prepared from neat CMPO (P-3) proves to be more retentive than that based on the 35 wt% CMPO - 5 wt% TBP mixture (P-2). Besides their usual acid dependence, Dw's show a marked decrease as a function of increasing atomic number (and decreasing ion size) along most of the Lanthanide series, from Pr to Lu (Fig. 6). This selectivity trend is opposite to that obtained with EXC materials based on other widely used ligands. Indeed, both the acidic organophosphorus extractants HDEHP or HEH[EHP] <sup>[25-27]</sup>, and the diglycolamide ligand TODGA <sup>[28, 29]</sup> display a continuously increasing affinity from La to Lu, interpreted to reflect the increasing charge density of the cations along the series. However, as already observed with the conventional TRU and RE resins, the Lanthanides do not exhibit a simple, monotonic variation of Dw's as a function of their atomic number and ionic size when they are extracted by CMPO. Instead, Dw's first increase from La to Pr and then decrease from

Pr to Lu, resulting in upwards concave, « hockey stick » shaped patterns. Such curved trends differ from predictions based on a simple relationship of D<sub>w</sub>'s to ionic radii. Indeed, the lanthanide ion size in aqueous solutions smoothly decreases across the series (the so-called « lanthanide contraction ») from 125 pm for La to 99.5 pm for Lu. [30] This very regular variation should rather suggest a monotonic extraction trend, with a maximum uptake of La. Similarly shaped patterns of D's for the lanthanide series, peaking at Pr or Ce, have been reported for a solvent extraction system using the diamide-type extractant DOODA(C8) in n-dodecane in 3M HClO<sub>4</sub> and 3M HNO<sub>3</sub>. [31, 32] This somewhat « anomalous » behavior of La and Pr in systems based on fairly different ligands, awaits for an explanation.

Another salient feature is the differential behavior of the light and heavy lanthanides as a function of increasing nitric acid strength. Specifically, the uptake of the lightest lanthanides decreases at high acid concentration (in >2M and >3M HNO<sub>3</sub> for P-2 and P-3, respectively) while, in contrast, the heavy lanthanides display an enhanced extraction (Fig. 7). This increase of D<sub>w</sub>'s has a marked atomic number dependence, thereby causing a large fall of the mutual fractionation of the heavy lanthanides as the nitric acid concentration increases: for both resins, D<sub>Gd</sub>/D<sub>Lu</sub> decreases from ~17 in 0.5M HNO<sub>3</sub> to 2.4 in 5M HNO<sub>3</sub>, or even 1.4 in 7M HNO<sub>3</sub> for P-3. These changes result in an anticlockwise rotation of D<sub>w</sub>'s profiles, around an axis located close to Eu when the nitric acid molarity increases. Eventually, almost flat patterns from Sm to Lu are achieved in 7M HNO<sub>3</sub>, in marked contrast with the steeply inclined profiles typically obtained in less concentrated acids (Fig. 8).

For both resins, in the 0.05M-3M HCl acidity range, distribution ratios of those elements having a clear affinity for the resin (lanthanides, actinides, Group 4) are much lower than those achieved in HNO<sub>3</sub> (Fig. 9). This might reflect the different properties of the Cl<sup>-</sup> and NO<sub>3</sub><sup>-</sup> anions which must be co-extracted in order to ensure the charge neutrality of the extracted CMPO-

metal complex. Indeed, albeit of similar charge and ionic radius, Cl<sup>-</sup> differs from NO<sub>3</sub><sup>-</sup> by a higher hydration energy (-317 vs -270 kJ mol<sup>-1</sup>) [33] which must be overcome in order for it to act as a counter anion. This effect would be less pronounced at high HCl concentration, as suggested by the strong, positive acid dependence of the extraction of the light lanthanides in HCl, opposite to the slight decrease of D<sub>w</sub>'s observed in nitric acid at elevated molarity (Fig. 9). From a practical point of view, the low D<sub>w</sub>'s of the light lanthanides in 1-3M HCl offer an efficient mean to strip quantitatively these elements following their extraction from nitric acid solutions.

## Noble metals, Selenium and Tellurium

A set of six noble metals (Au, Ir, Pd, Pt, Re, Rh, Ru) and two metalloids (Se, Te) have been investigated for their behavior on the P-2 resin, in HNO<sub>3</sub> and HCl media. Due to problems with the solubility of this element in nitric acid, data for gold are considered suspect and are not reported. The results can be summarized as follows. First, three of these elements do not show any extraction from both nitric and hydrochloric acids, namely Ru, Rh, and Se. In contrast, Pt and Re are extracted from both media, but with quite different acid dependences: while their D<sub>w</sub>'s decrease monotonously from 0.1M to 5M HNO<sub>3</sub> (Fig. 10 a), they define upward convex curves with a broad maximum in 1-3M HCl (Fig. 10 b). The behavior of Pd, Ir, and Te (not shown) is somewhat intermediate, that is, the extraction of Pd is significant in HNO<sub>3</sub>, with a negative dependence on acid strength, but negligible in HCl throughout the 0.1-6M range. Unlike this, Iridium and Tellurium are not extracted from HNO<sub>3</sub> media, but are weakly (Ir) or strongly (Te) retained from 3-4M HCl, with a marked dependence of the extraction of Te on acid strength. For the sake of comparison, the distribution ratios have also been determined for the conventional RE Spec resin (16% CMPO-24% TBP). As exemplified by the uptake of

platinum from HCl (Fig. 11), it appears that, for most extracted elements, the values obtained with P-2 (35% CMPO-5% TBP) are consistently larger than those achieved with RE Spec, thus indicating that CMPO plays a major role in the enhanced extraction.

#### **Effect of fluoride ion**

By virtue of its strong affinity for silicon, fluorine is commonly used to decompose silicate samples, either as an aqueous solution of HF, or in solid compounds (e.g., ammonium acid bifluoride NH<sub>4</sub>HF<sub>2</sub>) the higher boiling point of which allows higher temperatures to be achieved without resorting to high pressure devices. [34, 35] The resulting sample solutions contain variable amounts of F ion which, as a strong complexing agent for many elements, is likely to interfere with subsequent separation processes based on ion exchange or extraction. For this reason, the dependence of D<sub>w</sub>'s has been investigated for the P-1 resin (20 wt% CMPO-20 wt% TBP) in nitric acid containing varying concentrations of HF. It is noteworthy that even the nominally fluorine-free, multi-element nitric acid solutions used to measure Dw's do contain HF because this acid was typically used in 6:1 or 8:1 molar proportion to stabilize standard solutions of Ti, Zr, Hf, Nb, Ta, Mo, Sn and W. [36] The results highlight a clear adverse effect on the uptake of all the elements that are extracted to a significant degree from nitric acid media. In every case, this effect is more pronounced in dilute HNO<sub>3</sub> than in more concentrated (>1M) acid. However, in detail, the various groups of elements display different behavior. The uptake of Ti-group elements (Ti, Zr, Hf, Nb) is essentially suppressed (D<sub>w</sub>'s < 10) for the range (0.25-5M) of HNO<sub>3</sub> concentrations investigated (Fig. 12), in line with the notorious affinity of these elements for fluorine. This drastic fall of Dw's is followed by a weak recovery when the molarity of HF increases. The behavior of Ta is

in sharp contrast, with an enhanced extraction as the HF concentration increases from 0.07 to 0.29M, both in 0.25M and 1M HNO<sub>3</sub> (Fig. 12). This increasing trend is much weaker in 2.5M HNO<sub>3</sub>, and cancels out in 5M HNO<sub>3</sub>, in which Ta follows the same decreasing trend as the rest of the Ti-group elements when the HF concentration increases (Fig. 12).

As elements prone to complexing by the fluoride ion, the Actinides also display reduced extraction with increasing HF content. Thorium is very sensitive, as shown by the steep decline of its distribution ratios as a function of increasing HF (Fig. 13). In contrast, in spite of a significant effect, the tremendous affinity for U is largely preserved, with  $D_w$ 's > 1000 in nitric acid – hydrofluoric acid mixtures ranging from 1M to 5M HNO<sub>3</sub> at a fixed HF concentration of 0.29M. In dilute (0.25M) HNO<sub>3</sub> however, both Th and U display a different behavior, namely, a marked decrease of  $D_w$ 's in 0.07M HF, then a « rebound » at 0.145M HF, followed by a further decrease in 0.29M HF (Fig. 14).

The extraction of the Lanthanides also decreases as a function of HF concentration in the HNO<sub>3</sub>-HF mixtures (Fig. 15). In further detail, depicted in Figs 1 to 6 of Appendix A2, it can be seen that the light and the heavy Ln's do not respond in the same manner to the presence of increasing contents of HF in nitric acid of variable strength. That is, in 1M HNO<sub>3</sub>, the D<sub>w</sub>'s of light Ln (La-Nd) decrease regularly with increasing HF (Fig. A2-1) while the heavy Ln's (Er-Lu) show an upward concave trend with an increase of D<sub>w</sub>'s when HF rises from 0.145 to 0.29M (Fig. A2-2). In 2.5M HNO<sub>3</sub>, the initial decrease of light Ln D<sub>w</sub>'s is followed by an almost flat trend reflecting a vanishingly small effect of the F<sup>-</sup> ion on the uptake of these elements at relatively high nitric acid strength (Fig. A2-3). The heavy Ln's still display the same upward concave trends as those obtained in 1M HNO<sub>3</sub> (Fig. A2-4). Finally, in 5M HNO<sub>3</sub>, the differential behavior along the Ln series tends to cancel out (Fig. A2-5 & 6), reflecting the vanishing effect of fluoride complexing in more concentrated nitric medium.

As already observed for Th and U, the variation of Ln D<sub>w</sub>'s as a function of increasing HF in dilute (i.e., 0.25M) nitric acid is peculiar (Fig. A2-7). For the light and middle Ln's (from La to Dy), D<sub>w</sub>'s first decrease at 0.07M, then rebound in 0.145M, and eventually decrease again in 0.29M HF. In contrast, the heavy Ln's show regular, upward concave trends similar to those observed at higher HNO<sub>3</sub> concentrations. The similarly sinuous, non monotonic trends displayed, not only by the light and middle Ln, but also by Th and U (Fig. 14) suggest that, at low nitric acid concentration, the extraction of these elements is controlled by a complex interplay of their nitrate and fluoride species. Whatever its explanation, which is beyond the scope of this article, the differential response of these groups of elements to the presence of HF could be used to improve their mutual separation.

Albeit not belonging to the lanthanide series, scandium and yttrium are two additional Rare Earth Elements, which are significantly extracted by the CMPO-based resins. In every respect, Y behaves much like the heavy Ln Thulium. In contrast, albeit sharing some common features with the heavy Ln's, Sc follows more closely thorium concerning its overall strong affinity for the resin, and the dependence of its distribution ratios on the presence of HF. However, it is noteworthy that the extraction of Sc from nitric acid media is much more sensitive to the presence of F<sup>-</sup> ion than that of the LREE and Th (Fig. 13). This property might offer a way to selectively strip these two elements by an appropriate tuning of HNO<sub>3</sub>-HF mixtures.

#### Resin stability and column re-use

Earlier studies on the TRU resin (13 wt% CMPO-27 wt% TBP) reported appreciable shifts in the position of elution peaks after column rinses, interpreted to reflect preferential leaching of

the more soluble TBP at first, possibly followed by a loss of CMPO after further extensive rinses. [7] A ca. 30% increase of Vm, suggestive of the presence of empty pores, provided further evidence for a significant loss of stationary phase after prolonged (1000 FCV) column rinsing. [7] We lack hindsight to assess the long-term shelf-life of the resin prototypes. Also, no specific study of relatively short-term resin aging due to extractant leaching as been done, but the columns were re-used (up to 5 times) for separating sample solutions of geological samples without observing any significant change of the elution profile. Based on the extremely low solubility of CMPO in aqueous medium (estimated water solubility at 25°C ~0.01mg/L [37]), compared to that of TBP (280 mg/L at 25°C [38], it is anticipated that P-2 and P-3, containing a strongly reduced amount of TBP, or no TBP at all, respectively, should not suffer from serious loss of stationary phase, and could be re-used. However, due to the very strong uptake of the elements of interest, it will probably be quite challenging to reduce memory effects to extremely low levels, making the re-use of columns not recommendable, at least for those applications most demanding in terms of analytical blank. This does not seem to be a major concern, however, because the extreme column miniaturization permitted by the very high retention of the new EXC materials should make it possible to routinely use fresh resin, thereby ensuring low analytical column blanks, at rather reduced cost. Indeed, CMPO is not a very rare compound, which can be obtained from many companies [39] at a rather moderate price (~ 10 US \$ / gram). This would imply an extractant contribution of less than 0.5 US \$ to the cost of a micro-column filled with 100 mg of P-3 resin with 40 wt% loading of CMPO.

# Group separation of many high valence trace elements from natural silicate samples decomposed by alkaline fusion or by hydrofluoric acid attack

In order to highlight the real analytical potential of the new EXC materials developed in this work, column chromatography has been used to study the contrasting behavior of unwanted major and minor elements, and selected trace elements of interest in geological and environmental sciences. To achieve this goal, natural samples with complex matrices are well suited. Accordingly, three samples covering the compositional range of common silicate rocks have been chosen, namely an in-house standard of granitic composition (FAY), and two basaltic and andesitic international standard reference materials prepared by the U.S. Geological Survey (BCR-2, and AGV-1, respectively). While the basaltic and andesitic samples were brought into solution by conventional dissolution with hydrofluoric acid, the granite was decomposed by alkaline fusion with lithium metaborate. Although this procedure involves the addition of a three-fold excess of flux and does not remove Si from the sample as volatile silicon fluoride, it ensures a much more efficient attack of refractory accessory minerals hosting major amounts of Zr, Hf, Th, U, and Lanthanides in rocks typical from the continental crust. Also, this decomposition method gives a final, quenching solution without any added fluorine, thereby offering an opportunity to compare the extraction behavior of elements in F free and F bearing environments. The final resulting sample solutions, both in nitric acid medium containing a few tens of mg of ascorbic acid to reduce Fe(III) to Fe(II), have been passed through a column containing 100 mg of the neat CMPO resin, P-3. By virtue of the enhanced distribution ratios of that resin, it was possible to use a very short column (~ 7 mm high, ~ 7 mm internal diameter). The practical interest of such a stocky column was to permit a fast, gravity driven flow rate, most useful to

load the relatively large volume of solution obtained after sample fusion with LiBO<sub>2</sub>.

The elution behavior of major and trace elements on the short P-3 column loaded with the granite sample decomposed by fusion is displayed in Table 2. As predicted by D<sub>w</sub>'s data, almost all the matrix elements (Al, alkalis, alkali earths, etc.) are quantitatively removed from the column during the loading and initial rinse steps. Iron is retained to a minor degree (~6%) indicating that ascorbic acid was not able to reduce this element quantitatively, possibly due to the adverse effect of the relatively high (2.5M) nitric acid concentration. Tantalum, and to a lesser degree Nb, are weakly extracted, presumably because of their strong hydrolytic tendency in the absence of suitable complexing agent. Among major elements, only Ti is retained to a large extent. It is stripped almost quantitatively (~98%), along with Zr, Hf, and Nb in the next fraction of 2.5M HNO<sub>3</sub>-0.1M HF. At this stage, Th, U and the Lanthanides are still retained on the column, except the heaviest Ln's, particularly lutetium, as a reflection of their lower Dw's. It is inferred that this incipient breakthrough of Lu reflects, at least in part, a decrease of the capacity of the column caused by the extraction of significant amounts of Fe(III) and, in the absence of fluoride, titanium. These minor HREE losses could be prevented by using a longer column, a slightly lower molarity of HNO<sub>3</sub>, slightly reducing the volume of that fraction, or a combination thereof. In spite of the obvious disadvantage of such a short (~7 mm) column for this purpose, a gradient of decreasing HNO<sub>3</sub> molarity was used to study the sequential elution of the lanthanides. Specifically, a suite of fractions of 1M to 0.125M HNO<sub>3</sub> achieves the stripping of 95% of the heaviest Ln's and Y, while the lighter Ln's (from La to Gd) are still fully retained. These are almost quantitatively (99%) recovered by switching the eluant from 0.125M HNO<sub>3</sub> to 3M HCl. This medium would permit the on-line loading of a column of TODGA resin used in tandem to achieve the separation of individual elements, e.g., Nd in view of mass spectrometric measurements of radiogenic isotope ratios. [40] Then, dilute HCl allows recovering some two-thirds of Th but the addition of 0.145M HF is required to strip the last third, together with some 6% of U. Finally, the bulk of U is stripped with 1.45M HF. Bismuth,

which was not included in the measured distribution ratios, was also found in this fraction.

Additional work would be required to characterize the behavior of this element.

The elution of major and trace elements on the same very short (~7 mm) P-3 column loaded with the basaltic rock standard dissolved with a mixture of HF and HNO<sub>3</sub> is displayed in Table 3. Unlike the previous case, for which the volume of sample solution was commensurate to the high total dissolved solid content (TDS, consisting of the sample plus a threefold (wt/wt) amount of LiBO<sub>2</sub>), silicon was removed by evaporation from the sample dissolved with HF. This smaller TDS allows loading the column with a significantly reduced volume of solution, in this case 2.5 mL of 2.5M HNO<sub>3</sub>, instead of 6 mL. A few minutes before column loading, ascorbic acid (50 mg) was added to the solution to reduce Fe, present (along with other transition elements) in greater amount than in the granite sample. The data show that matrix elements (Al, alkalis, alkali earths,) including iron as Fe(II), behave passively and pass through the column during the loading step, along with minor transition elements (Ni, Co, Cu, Zn), Tl, and Pb. In marked contrast with the granite sample decomposed by fusion with LiBO<sub>2</sub>, the Ti-group elements (Ti, Zr, Hf), W, and Nb are essentially not retained, indicating they occur as non extractable species formed during the sample dissolution step with HF. However, Ta is quantitatively removed (along with Mo) from the sample solution, in line with its peculiar behavior compared to the rest of the HFSE (Fig. 12 a). The next fractions of 0.5 ml 2.5M HNO<sub>3</sub> totaling 3 mL (equivalent to roughly 25 free column volumes), do not contain any appreciable element except ca. 3% of Lu, highlighting the strong retention of the elements of interest extracted during the loading step. This indicates that samples of larger size, e.g., 200 mg of basaltic rock, could be processed on the same microcolumn. This suggestion is further supported by the fact that the next 2 mL of 2.5M HNO<sub>3</sub>-0.1M HF only contain the small amount of Ti, Zr, Hf, and Nb that was initially extracted,

along with *ca*. 1% of Lu, the least adsorbed Ln. The next two mL of 1M HNO<sub>3</sub> contain a few % of the heaviest Ln, and this fraction could be omitted to proceed directly to the stripping of the heavy Ln's with 2 mL of 0.125M HNO<sub>3</sub>.

Then, the light lanthanides are eluted in a very pure state with 1.5 mL of 3M HCl. The next fraction of 0.5 mL of the same acid contains 99% of Th, accompanied by ca. 15% of U, and 8% of Bi. The rest of U and Bi are stripped by means of 0.5 mL of 0.05M HCl-0.145M HF. This fraction also contains the bulk of Sc and about one forth of Mo found in this experiment. The complement of Mo can be stripped with 2 mL of 0.72M HF, but Ta remains strongly held by the resin. It was found necessary to resort to a very strong, water soluble, organic complexant designed as a stripping/holdback reagent for multivalent (M<sup>>/</sup> +3) metal ions in SEX schemes, [41] namely, 1-hydroxy ethane-1,1 diphosphonic acid (HEDPA, also known as etidronic acid) to back-extract that element.

In conclusion, these preliminary experiments conducted on natural, complex matrices demonstrate the potential of the neat CMPO resin (P-3) for the selective, high yield separation of many trace elements of interest (the REE: Ln + Sc and Y; Th, U, plus Zr-Hf in case F<sup>-</sup>-free solutions are processed) from all those common elements forming geological and environmental samples. These elements are obtained in a very pure state, as shown by the decontamination factors (that is, the ratio of the amount of unwanted element accompanying the element of interest after and before the separation) achieved in the different fractions (Table 4). Irrespective of the sample decomposition method, the results lie in the 10<sup>-4</sup> to 10<sup>-5</sup> range in most cases, which is a good achievement for a single pass column separation. However, in the case of a decomposition of the sample by melting, a significantly poorer decontamination of Ti and Zr is achieved, reflecting the strong initial extraction of these elements from F<sup>-</sup> free solutions. Although additional work is still required to refine the composition of successive

elution media, the data available at present suggest that sequential stripping of the main groups of elements extracted should be possible. The comparison between the experiments conducted with solutions prepared by LiBO<sub>2</sub> fusion or dissolution with HF confirm that the extraction of certain high valence elements by CMPO is highly sensitive to the presence of the fluoride ion. Specifically, their extraction is greatly (Ti, Zr, Hf) or notably (Nb) reduced when hydrofluoric acid was involved in the sample preparation steps preceding the column separation. In contrast, and as anticipated from the measurements of distribution ratios in HNO<sub>3</sub> containing HF, the extraction of Ta is enhanced when the sample was treated with an excess of hydrofluoric acid during the dissolution step.

# Extraction from hydrochloric acid medium

The distribution ratios of trace elements extractable by CMPO such as the REE, Th, and U are in general much lower in HCl medium than in nitric acid, at least at low to moderate acid strength. However, the new resins might offer interesting prospects to separate a few trace elements which are not extracted in nitric media, but display relatively high Dw's in HCl, such as certain noble metals. Among them, rhenium, occurring at ultra-trace level in geological materials, is important in radiogenic isotope geochemistry, due to the natural chronometer and isotopic tracer offered by the long-lived radioactive decay of <sup>187</sup>Re into <sup>187</sup>Os. To investigate the potential interest of the CMPO resins in this scope, a 100 mg aliquot of the AGV-1 andesitic SRM has been dissolved with HF, evaporated to dryness, spiked with 30 ng Re, and redissolved with 1 mL of 1M HCl. After addition of 35 mg of ascorbic acid as a reducing agent for Fe(III), this solution was loaded onto a ca. 5 mm i.d. column containing 100 mg of P-2 resin. Then, the column was rinsed with 0.5 mL of 1M HCl, and further washed with 4 x 0.5 mL of 0.05M HCl. The results listed in Table 5 show that this step allows to get rid of most major, minor, and trace

elements, while Re is quantitatively extracted. Several trace elements are also retained to a significant extent, namely, Sn, Cd, Sb, Nb, W, Bi, and, especially, Mo and Ta. Although the extraction behavior of Nb, Mo, Ta, and W is consistent with their high distribution ratios measured in HCl medium, it turns out that Zr and Hf were not extracted, in spite of similarly high Dw's. This suggests that these two elements occurred as non extractable fluoride complexes. The major part of the retained elements can be removed from the column by means of 6 x 0.5 mL 0.1M HNO<sub>3</sub>, while Re is still held by the resin. Finally, Re is stripped with 1.5 mL of 4M HNO<sub>3</sub>. This Re fraction still contains impurities of Ta, W, Mo, Nb, and Sn, but preliminary work indicates that these unwanted elements could be efficiently filtered off by loading the Re fraction on-line onto a column of HDEHP-based EXC material (LN resin of Eichrom). Indeed, Re is not extracted by HDEHP from 4M HNO<sub>3</sub>, whereas Ta, W, Mo, and Sn are retained. Although promising, this scheme should be significantly up-scaled in order to handle the much larger samples sizes necessitated by the exceedingly low concentrations of Re in most natural samples. But it is suggested, that this protocol might prove useful for isolating Re from matrix elements in view of precise concentration measurements by isotope dilution mass spectrometry, either by N-TIMS or ICP-MS.

# Mutual separation of the heavy lanthanides

Finally, a preliminary experiment has been conducted to explore the possibility to isolate individual Ln from adjacent elements. This trial was prompted by the observation that distribution ratios of the mid and heavy lanthanides on both the P-2 and P-3 resins in dilute nitric acid decrease markedly as a function of increasing atomic number, i.e., following a trend reverse to that observed for other EXC systems based on HDEHP or TODGA. This suggests that a CMPO based resin might offer an alternative, or complementary, way to fractionate the

heavy Ln's. Taking the heaviest lanthanide, lutetium, as example, a roughly similar magnitude of extraction (e.g., D<sub>w</sub> ~12) would be achieved in 1M, 0.2M, and 0.15M (interpolated values) HNO<sub>3</sub> for RE, P-2, and P-3 resins, respectively, with a modest improvement of its separation factor from Yb (taken as the ratio of their D<sub>w</sub>'s) from 1.2 with RE to ca. 1.5 with P-2 and P-3. A moderately long (~7 cm), ~4 mm i.d. column containing 310 mg of P-2 resin was tested with an artificial mixture containing 50 ng of each of the six heavier Ln's: Dy, Ho, Er, Tm, Yb, and Lu. Following sample loading in 50 µL of 1M HNO<sub>3</sub> followed by 150 µL of the same acid to ensure the sorption of the elements on top of the column, the resin was washed with 3 mL of 0.25M HNO<sub>3</sub> which did not desorb any element. Then, the chromatographic separation was continued by decreasing the nitric acid strength from 0.15M to 0.05M, with two intermediate steps of 0.10M and 0.08M HNO<sub>3</sub>. This caused the sequential elution of the Ln's in the reverse order of their Dw's. The results show (Fig. 16) that the most strongly held elements, Dy and Ho, are well separated from each other in 0.05M HNO<sub>3</sub>. However, the peaks of Ho and Er are not perfectly resolved, and the overlap between adjacent peaks is even more important for the less retained Lu and Yb. This indicates that a longer column (and possibly of wider internal diameter, depending on the amount of heavy Ln's to be separated) would be required to improve the resolution of the chromatographic peaks of these elements. Also, the concentration gradient of the eluting medium could be optimized. In case only one of these elements is targeted, the P-2 column could be used in tandem with another column of LN resin (featuring a reverse order of

## Other potential use

Besides separation applications, it would also be possible to take advantage of the extreme affinity of the neat CMPO resin for many important trace elements in fairly concentrated, 5-7M

nitric and 6M hydrochloric acids, to remove traces of contaminants from these reagents, as an alternative to, or combined with, sub-boiling distillation. For example, this approach might be helpful for an ultimate "polishing", just prior to use, of small volumes of acids in very demanding applications such as radiogenic or stable isotope chemistry where ultra-low blanks of selected elements are required.

#### CONCLUSIONS

Compared to the well-established TRU- and RE-Spec EXC materials based on CMPO largely diluted with TBP, the new resins developed in this work with little or no TBP display greatly enhanced distribution ratios for the trace elements of interest over the range of nitric acid concentration (1-3M) most appropriate for handling samples in solution. This includes the heaviest lanthanides which suffered from limited uptake by TRU and RE resins in <3M HNO<sub>3</sub>. The excellent selectivity against those elements constituting the bulk of natural samples is maintained. Only Fe (III) is potentially troublesome, but thanks to the improved Dw's in relatively dilute (ca. 2M) HNO<sub>3</sub>, this problem can be more easily circumvented by using ascorbic acid to reduce trivalent iron to the non extracted, divalent species. The high Dw's allow a very high degree of miniaturization of separation protocols to be achieved. Combined with fast uptake kinetics, they permit to use very short columns, thereby ensuring the selective extraction of trace elements of interest at a high flow rate. This is most useful when relatively large volumes of sample solution are to be processed, as is the case when silicate samples are decomposed by alkaline fusion. From such fluoride-free, nitric acid media, all the main target elements of many geochemical studies (REE, Th-U, and HFSE) can be quantitatively separated from unwanted matrix elements. When sample are dissolved by using HF, the extraction of REE, Th, and U is still quantitative, but that of most HFSE is greatly reduced, as a result of the

extreme sensitivity of these elements to fluorine complexing. The same nitric acid solutions could also be loaded onto Sr Spec column for the concomitant separation of Sr and Pb. Besides their obvious interest for fast, group separations with very short columns, the new CMPO resins could also be used in sufficiently long columns to achieve the mutual separation of the heavy lanthanides in dilute nitric acid, by virtue of the marked fractionation of their  $D_w$ 's as a function of increasing atomic number. Finally, the CMPO resins might prove useful in HCl media for the separation of certain noble metal from matrix elements, thus broadening their potential field of application.
