1 . Introduction

At th e indu stria l scale, polyet hylen e (PE) ca n be ma n ufa cture d by a huge number of processes, which contributes to its place as the worldwide most consumed polymer [1]. Among these processes, Machine Dire ction Or ientation (MDO) co nsist s in drawin g a polyme r film belo w it s melting temperature (''cold drawing'' process) to enhance several of its properties (e specially mechan ical, optica l an d ba rrier ones) whil e re ducing the amount of matter necessary to reach them [2–4]. The unit used to pe rform this proces s is co mpose d of a series of roll s su bdivide d into four area s co rrespon din g to th e co nse c utive step s of th e process, *i.e.* preheating, drawing, annealing and cooling [2,4]. Preheating rolls are intended to heat uniformly the film before it is drawn between two rolls ("slow driv e " SD an d " fas t driv e " FD). Passin g on heated annealin g roll s enables thermal stabilization of the drawn film, especially its shrinkage ability. Fina l step s co nsist in coolin g th e film to room te mpe r ature on wate r -cooled roll s an d winding. Th e draw rati o (DR) is finall y define d as th e rati o betwee n th e speeds of th e last coolin g roll an d th e firs t pr e heatin g roll .

It is known that, upon uniaxial drawing, the initial spherulitic morpholog y of semi -crystallin e PE is pr ogressively tran sformed into a fi bri l la r stru cture [5 –[10](#page-9-3)]. Se veral mo del s have been pr opose d to explai n this transformation, involving either crystallographic slips and interlamel-lar processes [[5](#page-9-3)–7,[9](#page-9-4)[,11](#page-9-5)–14] or melting-crystallization [5,[6](#page-9-6),[9\]](#page-9-4). Accordin g to th e crysta llographi c model, in itial lame lla e ar e fragmented into smalle r crystallin e blocks by mean s of mechan ica l twinning , stress induce d martensiti c phas e transition an d crystallin e slips, associated with interlamellar processes (shear, separation and lamellae-stack rotation). Melting-crystallization involves local stress-induced melting, givin g birt h to ne w smal l crystallin e blocks upon crysta llization . As a result of both mo dels, microfibrils or iente d alon g th e drawin g dire ction (her e afte r called th e MD) ar e formed [\[15](#page-9-7) –18], whic h ar e co mpose d of smal l crystallin e blocks co nnected by amorphou s chains .

A co nsequence of this mo rpholog y transition is th e improv ement of se veral properties of PE when co mpare d to an undraw n sa mpl e of same thickness, *e.g.* optical properties (increased transparency and gloss, re-duced haze) [19–[21\]](#page-9-8), mechanical properties (enhanced Young modulus alon g th e MD an d TD – Tran svers e Dire ction – an d stress at brea k alon g th e MD , decrease d defo rmation at brea k alon g th e MD) [\[19](#page-9-8) –22] an d

barrier properties (lower permeability to oxygen and water vapour) [[19](#page-9-8) [,22](#page-10-0)]. Ho wever , it should be note d that , despit e se veral decade s of use at the industrial level [[23\]](#page-10-1), the MDO process and its consequences on th e properties of PE have received li ttl e inte res t from a fu ndame nta l poin t of view [\[19](#page-9-8) –22 ,24 –[27\]](#page-10-2), with no me ntion of ph otoag eing.

sional is a magning of μ and μ and Polyethylene, like all polymers, is prone to degradation under enviro nme nta l stresses (heat, UV ligh t …), which, in th e presence of ox ygen, involves an oxidative chain radical process [\[28](#page-10-3),[29\]](#page-10-4). The consequence of (photo)ox idation is a pr ogressive degr adation of th e properties of PE . St abili zer s ar e then ofte n used to slow down this process, *e.g.* ph enoli c antiox idants, Hi ndere d Amin e Ligh t St abili zer s (HALS) or UV absorber s [[30\]](#page-10-5). The consequences of the sole morphology modification caused by the MDO drawing on the photodegradation of PE has never been studie d so far. Ho wever , in a recent work , we reported on th e co nsequence s of MD O pr ocessin g on th e so l ubi lit y of a bloo min g HALS (Tin uvin® 770) in PE, and the impact on the polymer photostability [[27\]](#page-10-6). It was shown that the solubility of Tinuvin® 770 in PE was increased consecutive to MD O drawing. Ho wever , draw n film s were more pron e to ph o todegr adation in acce lerated co ndition s than undraw n ones . This wa s attributed to th e fact that th e tota l amount of HALS (*i.e.* both so l ubl e an d pr eci p itate d at th e su rface) wa s lowe r afte r MD O pr ocessing.

Whil e th e ph otodegr adation of PE unde r simu ltaneou s drawin g ha s been extensively reported [\[31](#page-10-7)–36], the effect of preliminary orientation on it s ph otost abi lit y is more co nfide ntial [37 –[40\]](#page-10-8). It ha s been reported that pr e -oriented PE sa mples were less pron e to degr adation [[37](#page-10-8) [,38](#page-10-9) [,40\]](#page-10-10), whic h ha s been explaine d by a decrease in th e tran sport properties of O_2 in the drawn polymer [37]. However, annealing (either with fixe d or free ends) le d to th e same degradabilit y of draw n PE as that of an undraw n film [38].

The work reported here is dedicated to the effect of the MDO drawin g on th e or ientation , crystallinit y an d pe rmeabilit y of PE film s an d th e co nsequence s of thei r ph oto x idation on thes e fe atures. Or ientation caused by th e MD O pr ocessin g wa s firstl y characte rized by XR D an d po larized FTIR spectroscopy. Crystallinity and oxygen permeability were also assessed prior to photoageing. Photooxidation kinetics of undrawn an d draw n film s were then co mpared, an d th e co nsequence s of ph o tooxidation on crystallinity, orientation and oxygen permeability were studied and correlated to the modification of the polymer structure.

2 . Experimental

2. 1 . Sample compositio n an d preparatio n

Th e PE film s used hereafte r ar e sy mme tri c thre e -laye r sy stems (15/ 70/15 %) that combine one grade of LDPE (density = 0.923 g cm⁻³, MF I(190 °C , 2.16 kg) = 0.25 g/10 min) an d tw o grades of LLDP E (den sity = 0.920 g cm⁻³, MFI(190 °C, 2.16 kg) = 0.50 g/10 min; density = 0.937 g cm⁻³, MFI(190 °C, 5 kg) = 2.00 g/10 min). They were prepared by Barbier group (Sainte-Sigolène, France) by blown coextrusion with three extruders A, B and C (screw diameter $D = 70, 105$ and 70 mm respectively; screw length $L = 30$ D for all). The films studie d here co ntain no st abili zin g agent, except from pr ocessin g ph enoli c antiox idant s in itially pr esent into th e ra w PE pe llets . Re ference un draw n film s (calle d " P E - 1 ") were obtained by blow n co -extrusio n to a fina l thic kness of abou t 45 μ m . MD O -processe d film s at a draw rati o of 4 ("PE - 4 ") were also ma n ufa cture d by blow n co -extrusio n (initial thic k ness 155 μm) before MDO processing up to a final thickness of about 45 μm. Temperatures of the MDO rolls during drawing are summarized in [Tabl](#page-2-0) e 1 .

It should be emphasized that blown extrusion caused some orientation for both PE-1 and PE-4 (*vide infra*) [24], and that undrawn (in the case of PE -1) does no t mean no n -oriented .

2. 2 . Irradiatio n

Artificial acce lerated ph otoag ein g of th e sa mples wa s ca rried ou t in a SEPA P MH E device from Atlas. It is co mpose d of a si ngl e medium pressure me rcury lamp (100 0 W) able to emit ligh t inte nsities rangin g from 90 to 300 W m^{-2} between 290 and 420 nm. Samples are located on a carousel rotating around this central lamp. Two temperature controllers are present within the unit: *i*. a thermocouple located outside the carousel ("Chamber Temperature", CHT), *ii*. a blackbody panel present on th e carousel ("Blac k Standard Te mpe r ature " , BST) . Al l th e ex periments were performed at a light intensity of 90 W m^{-2} and a CT/ BST couple of 60/70 °C in presence of air.

2. 3 . Heating

Co ntrol expe r iment s were pe rformed in th e presence of ai r within a forced convection oven from Binder regulated at a temperature of 60 °C , co mparabl e to th e CH T in th e irradi ation device .

2. 4 . Infrared spectroscopy

Fourier-Transform InfraRed (FTIR) spectra (4000-400 cm⁻¹, 32 scans, 2 cm⁻¹ resolution) were recorded in transmission mode with a Nicolet 6700 spectrometer from ThermoFisher equipped with a DTGS-KB r dete ctor. Dr y ai r purgin g is ensure d within th e anal ysi s chambe r in order to remove parasite bands from ambient air (water vapour, carbon dioxid e …). Spectr a were no rma lized by th e absorbance of th e 1378 cm^{-1} band (symmetric bending of end-of-chain –CH₃ groups [[41\]](#page-10-11)) to compensate for differences in thickness between the samples. Polarized FTIR spectra were obtained by introducing a ZnSe grid polarizer ahea d of th e sa mples at tw o angles (0 an d 90°) .

2. 5 . X-ray diffractio n

For the preliminary characterization of the structure and the texture of th e PE films, a X -Pert Pr o di ffractomete r (Malvern Pa n aly t ical) in Brag g Be ntano geom etr y with Cu K α radi ation wa s used . *FullProf Suite* software [\[42](#page-10-12)] was used for the profile refinement of XRD data of samples usin g th e Thom pso n –Co x –Hastings (TCH) peak pr ofile function . Gaussian contribution was kept constant whatever the direction, while Lorentzian contribution was free to change. NIST SRM ${\rm LaB_6}$ standard was used to determine the instrument resolution. The integral breadth method wa s used to ca lculate th e vo lum e -averaged appa ren t size of th e coherent domains along the [110] and [100] directions considering (110) and (200) reflections respectively $[43]$ $[43]$. LaB₆ NIST standard was used to co rrect fo r instrume nta l broa dening.

The degree of crystallinity $\chi_{\rm c}$ of bulk PE was determined by comparing the area of the amorphous hump to that of the crystalline peaks. The crysta llite size wa s estimate d usin g Sche rre r method , whic h relate s th e peak broadening of each Bragg peak (βhkl) to a characteristic average volume-weighted domain size D_ν in hkl direction. The integral breath $β_{hkl}$ values were obtained from fitting (110) and (200) peaks with a pseudo -Voig t function usin g Wi nPLOT R pr ogram an d co rrected from instrumental broadening using ${\rm LaB_6}$ as standard material.

To further probe preferred orientation and crystallization phenomen a upon drawing, smal l an d wide -angl e X -ra y scatte rin g (SAXS/ WAXS) me asurement s were pe rformed on PE film s on an Empyrean di ffractometer (Malvern Panalytical) with Cu K_{α} radiation using the line/ poin t co llimation setup, an elli pticall y bent 1D graded focu sin g mi rror, the ScatterX⁷⁸ chamber and the GaliPIX^{3D} detector. Films were clamped on a base holder an d th e me asurement s were done in tran smi ssion mode perpendicular to the film surface (six scans of 30 min each). Full 2D -WAXS pa ttern s with 360° azimutha l co verag e were recorded within a 2 θ rang e from − 30.55 ° to +30.55°. 1D -SAXS pa ttern s were recorded from 0.05° to 8 $^{\circ}$ (q = 0.05–5.68 nm⁻¹ where q denotes for the scattering vector $q = 4\pi sin(\theta)/λ$). The 1D-SAXS and 2D-WAXS data were processe d usin g EasySAXS an d XRD2 Dscan software s respectively (Malvern Panalytical).

2. 6 . Therma l analysis

A 3+ Di ffe rential Scanning Calorimetr y (DSC) apparatu s from Me t tler Toledo was used for thermal analysis. A heating-cooling-heating cycle (from −20 to 160 °C at 10 °C/min) was applied to samples of 10 –15 mg placed into al uminium cr ucibles an d unde r dr y ai r atmo s phere. Melting enthalpy of each sample was compared to that of a 100 % crystalline PE (293 J g^{-1} [[44\]](#page-10-14)) to calculate the mass degree of crystallinity $\chi_{\rm c}$. Thermal history of the polymer was taken into account by usin g data from th e firs t heatin g step .

2. 7. Oxygen permeability

Ox yge n Tran smi ssion Rate (OTR) were me asure d at 23 °C with a 8003 Ox yge n Pe rmeatio n Analyser from Sy stech Illinois . Afte r co mplet e purge under nitrogen, samples of 5 cm^2 were exposed to pure oxygen (1 atm) in th e to p part of th e anal ysi s chamber, whil e tran smi tte d ox y ge n mo l ecule s ar e headed toward s a coul ome tri c dete cto r in th e bo tto m part by a flux of oxygen-free nitrogen. OTR (in cm³(STP).cm⁻ $^{2}.s^{-1}$ were converted nverted into pe rmeabilit y coefficien t P (i n $\text{cm}^{-3}(\text{STP})$.cm.cm⁻².s⁻¹.Pa⁻¹) to take into account the thickness z of each sample (as well as the difference of oxygen pressure ΔP between the top and bottom parts of the chamber) with:

3 . Result s an d discussion

3. 1 . Effect of th e MD O processing

Undrawn PE-1 and MDO-drawn PE-4 were compared prior to photo x idation in term s of or ientation (through XR D an d pola rized FTIR spectroscopy), degree of crystallinity $\chi_{\rm c}$ (determined by XRD and DSC) an d ox yge n pe rmeabilit y to assess th e effect of th e MD O drawin g process.

3.1. 1 . Orientatio n

The XRD patterns in reflection Bragg Brentano geometry of undraw n PE - 1 an d MD O -draw n PE - 4 film s prio r to ph otoox idation ar e show n in [Fig.](#page-3-0) 1 . They ar e ty p ica l of semi -crystallin e polymers with well defined high intensity peaks corresponding to the crystalline part, while th e amorphou s part give s rise to di ffuse X -ra y scatte rin g an d strong halo fe ature s at th e Brag g peak locations. Peak s that appear at 21.44° , 23.76° an d 36.10° co rrespond, respectively , to th e di ffraction planes (110), (200) an d (020) of th e orthorho mbi c cell of polyet hylen e in Pnam spac e grou p [[45\]](#page-10-15). Orthorho mbi c an d mo n oclinic ar e th e tw o main type s of unit cells in PE, the former being the most common. In the orthorhom-

bic cell, the macromolecular chains of PE run along the c-axis [5,7] and *hk*0/0k0 reflections refer to interchain distances.

when the measurement of the section of the measurement of the measurement of the measurement of the measure Th e ne t increase in FWHM upon drawin g clearl y show s that th e MD O proces s caused a decrease of th e crysta llite dime nsions, whic h is confirmed by the calculation of the crystallite size D_ν [\(Tabl](#page-3-1)e 2). This is co nsi stent with th e mo rpholog y change reported upon drawin g (fro m spherulitic to fibrillar, *vide supra*) during which lamella are fragmented into smalle r crysta llites. A reorganization of th e in -plan e or ientation of th e chains upon drawin g ca n also be readil y seen on th e XR D pa ttern s of PE - 4 film s with th e ne t increase of th e inte nsity of th e (200) reflection with respect to the (110) reflection ([Tabl](#page-3-1)e 2). The $I_{(200)}/I_{(110)}$ intensity rati o ca n be co nsi dered as re presentin g a re l ative or ientation , that is often associated to chain drawing, and its increase suggests the formation of an extended chain crystal structure. When the crystallites in a sample are randomly distributed in space, it is known that $I_{(200)}/I_{(110)}$ is in an order of 0.2–0.25 [[46\]](#page-10-16). The value obtained here for the undrawn sampl e PE - 1 around 0. 1 indicate s a weak (110) or ientation , whic h coul d be attributed to th e blow n extr usion proces s used to pr epare th e film s [\[24](#page-10-2)]. On the other hand, the value calculated for the drawn sample PE-4 larger than 1. 0 clearl y indicate s a (200) PE crysta l or ientation . Th e in creased in PE (200) facet can be usually achieved via high drawing ratio [\[47](#page-10-17)]. This is consistent with the fact that drawing of PE often proceeds by alig nment of th e c -axis of th e orthorho mbi c cell (chain axis) in th e drawin g dire ction (her e th e Machin e Dire ction , MD) [[20](#page-10-18) [,22](#page-10-0)].

Another interesting observation is the presence of a small shoulder at ca. 19.5° in the XRD pattern of the drawn samples, which could be at-

tributed to amorphou s scatte rin g in ou r sa mples whos e degree of crys tallinit y is lowe r than 60 %.

2D -WAXS expe r iment s ca n also be used to qual itatively co mpare crystal orientation in samples $[20-22, 24-26, 48, 49]$ $[20-22, 24-26, 48, 49]$ $[20-22, 24-26, 48, 49]$ $[20-22, 24-26, 48, 49]$. The 2D-WAXS pattern s of PE film s showin g di ffraction ring s of th e (110) an d (200) la ttice planes are displayed in [Fig.](#page-4-0) 2, where the equator and meridian are defined as the horizontal direction (Transverse Direction, TD) and vertical dire ction (MD) , respectively .

Both pa ttern s show tw o di ffusion ring s associated to th e (110) an d (200) planes of th e crysta llites. Th e inte nsity of th e ring s fo r PE - 1 ar e homogeneousl y di stributed in space, except fo r a slight co nce ntr ation pa ralle l to th e MD that ca n be attributed to th e blow n extr usion proces s (*vide supra* [\[24](#page-10-2)],). This is consistent with a spherulitic morphology, whic h wa s indeed observed by pola rized microscopy fo r PE - 1 bu t no t for PE-4 (see Fig. S1 in the ESI). Rings for PE-4, in contrast, are strongly co nce ntrated pa ralle l to th e MD . This ca n be attributed to an or ienta tion of th e crysta llite s with th e chai n axis or iente d preferentially alon g the MD $[20-22,24,26,50]$ $[20-22,24,26,50]$ $[20-22,24,26,50]$ $[20-22,24,26,50]$ $[20-22,24,26,50]$ $[20-22,24,26,50]$. These results actually reveal the modification of th e polyme r mo rpholog y upon drawing: in itial lame lla e were br oke n into smalle r crystallin e blocks co nnected by amorphou s chains or iente d alon g th e MD in th e fi bri lla r stru cture .

For a quantitative examination of crystal orientation, the correspon din g azimutha l inte nsity curves of th e (110) an d (200) la ttice planes ar e also show n in [Fig.](#page-4-1) 3 wher e th e azimutha l angles of 0° (180°) an d 90 ° (270°) ar e define d as th e equato r an d meri dia n dire ctions, re spectively .

Although of low intensity, the observation of distinct peaks on the azimutha l scan s fo r undraw n sa mples co nfirm s th e weak or ientation of PE in them (Fig. 3a). The maximum intensity of (110) was found to locate at about 30° relative to the equator, and the maximum intensity of (200) wa s foun d in th e meri dia n region with zero scatte rin g on th e equator. A change in crysta l or ientation is observed upon drawing, with crystals or iente d alon g th e equato r as ev idenced by th e obse rvation of tw o shar p an d intens e peak s at 0° an d 180° in th e (110) azimutha l di s tr i b ution (Fig. 3b) . Th e ma x imu m inte nsity of (200) wa s also foun d in

th e equato r region with no more vi s ibl e scatte rin g inte nsity at th e meri dian.

Th e arrang ement of both (110) an d (200) di ffraction s in th e dire c tion vertical to the drawing direction MD demonstrates a c-axis orientation of th e PE crystals alon g th e drawin g dire ction , that is co nsi stent with th e reported mo rph olo g ica l change from spheruliti c to fi bri llar. It wa s no t po ssibl e to dete rmine th e crystallin e axis or ientation fa ctors from 2D-WAXS patterns because of the low signal to noise ratio measured.

In addition to XRD, it is also po ssibl e to quantify th e or ientation of chains with respec t to th e MD by ca lcula tin g th e or ientation function $f_{\rm c,MD}$ (Eq. [\(2](#page-5-0))) using polarized FTIR spectroscopy [20,26,48,49,50]:

 $\phi_{\rm c,MD}$ represents the angle between the c-axis of the unit cell (hence the polymer chains) and the MD. $f_{\rm c,MD}$ values range between -0.5 $(\phi_{c,MD} = 90^{\circ})$ and 1 $(\phi_{c,MD} = 0^{\circ})$.

Calculation of $f_{\rm c,MD}$ can be carried out using the dichroic ratio D dete rmine d from pola rized FTIR expe r iment s with Eqs. (3) [an](#page-5-1) d (4).

and A_{\perp} represent the absorbances taken from a spectrum recorded with IR light polarized parallel and perpendicular, respectively, to the MD .

with α the angle between the transient dipole moment of the vibration an d th e i -axis [48,49].

For PE, the intense 720/730 cm^{-1} bands (Fig. 4) can be used for this pu rpose , as thei r transition dipole moment s ar e or iente d alon g th e b and a-axis respectively (*i.e.* $\alpha = 0^{\circ}$ in Eq. (4)) [51–54]. It enables the calculation of $f_{\text{b},\text{MD}}$ and $f_{\text{a},\text{MD}}$ respectively, from which $f_{\text{c},\text{MD}}$ can be deduce d with th e orthog ona lit y relation [49]:

It can be observed in [Fig.](#page-5-2) 4 that the ratio between A_\parallel and A_\perp for the $720/730$ cm^{-1} bands measured for PE-1 and PE-4 are different. This evidences a di ffe ren t or ientation of th e chains into th e tw o sa mples . As this co mplex broa d band is actually a co nvolution of tw o crystallin e bands located at around 720 and 730 cm^{-1} and an amorphous one at 723 cm^{-1} [55], the calculation of the dichroic ratio required at first a mathematical curve-fitting (see details in the ESI). Results of $f_{\rm a,MD}, f_{\rm b,MD}$ and $f_{\rm c,MD}$ are reported in Table 3. Values of $f_{\rm c,MD}$ thus obtained are similar to those calculated from the crystalline bands at 1051 (–CH $_{2}$ – twisting, $\alpha = 0^{\circ}$) and 1896 cm⁻¹ (combination of -CH₂- rocking modes at 1168 cm⁻¹ and 720/730 cm⁻¹, α = 90°) [[56](#page-10-21),[57\]](#page-10-6), which can be used without any mathematical treatment of the spectra but suffer from low absorbance va lue s (Tabl e S1). Or ientation fa ctors *fi,MD* ca lculate d here ar e co nsi stent with thos e reported in [\[24](#page-10-2)] fo r a blow n -extruded film prio r an d afte r MD O pr ocessin g at a draw rati o of 4.

It can be observed that $f_{\rm b,MD}$ remained constant from PE-1 to PE-4, while $f_{\rm a,MD}$ decreased and $f_{\rm c,MD}$ increased. Similar changes have been reported for MDO-drawn films in $[20,24]$ $[20,24]$, with a- and b-axis preferentially or iente d alon g No rma l Dire ction (ND) an d Tran svers e Dire ction (TD) , respectively , upon drawin g [25]. Upon MD O pr ocessing, a - an d c axis then rotate d around b -axis in opposite dire ction s with respec t to the MD (respectively opposite to and toward the MD). Decrease of $f_{\rm a,MD}$ upon MD O drawin g is on e of th e characte ristics of roll -to -roll draw n films, while increase of $f_{\rm c,MD}$ confirms that MDO processing leads to an or ientation of th e c -axis of th e orthorho mbi c unit cell (*i.e.* th e polyme r chains) along the drawing direction.

3.1. 2 . Degree of crystallinity

MD O pr ocessin g of PE film s ha s ofte n been associated with a mo der at e increase of thei r degree of crystallinit y caused by stress -induce d crysta llization [\[20](#page-10-18) –22], se ldo m th e absenc e of an y change [[25\]](#page-10-23). Th e de gree of crystallinity $\chi_{\rm c}$ [\(Tabl](#page-5-5)e 4) was calculated in the present case from DS C (r ati o of th e meltin g enthalpy to that of a 10 0 % crystallin e PE [44]) an d XR D expe r iment s (calculate d by co nsi derin g th e integrated intensity of the features related to the amorphous and crystalline components). Within the experimental error, results from DSC and XRD are co nsi stent with each othe r an d show that th e degree of crystallinit y of ou r sa mples wa s no t affected by th e MD O pr ocessing.

3.1. 3 . Oxygen permeation

The mechanism of permeation can be decomposed into three consecutive steps: *i.* solubilization of the penetrant at the polymer surface, *ii.* diffusion from the entrance to the exit surface, *iii.* desorption at the la tter. Th e firs t an d thir d step s ar e associated with th e thermodynami c solubility coefficient S, while the second one is related to the kinetic dif-

fusion coefficient D [\[58](#page-10-24)–61]. The ability of a penetrant to cross a polyme r film is ultimately re presented by it s pe rmeabilit y coefficien t P de fine d as :

It ha s been demo nstrate d that crystallin e region s ar e so densel y packed that they ar e impe rmeable , whic h restrict s both th e sorption an d th e di ffusion to th e amorphou s region s of semi -crystallin e polymers such as PE [[62\]](#page-10-7). As a co nsequence , S ca n be expresse d as a function of the volume degree of crystallinity χ_c by:

with S_a the solubility coefficient of the amorphous phase. From the fractional free volume (FFV) theory $[63]$ $[63]$, S_a can be defined as:

 f_a stands for the fractional free volume of the amorphous part, f_1 for the fractional free volume of the penetrant, p_T for the liquidvapour equilibrium pressure of the gas and χ_1 for the Flory-Huggins paramete r of th e (pen etran t -polymer) sy stem.

In addition , th e presence of crysta llite s restrict s th e di ffusion of th e pe n etran t mo l ecule s as a co nsequence of th e to rtuosit y an d th e li m ita tion in mobi lit y of th e amorphou s chains clos e to th e crystallin e region s [[62\]](#page-10-7). These two effects are considered in the FFV theory through the tortuosity factor τ and the immobilization factor β respectively [63].

Th e MD O -processe d film is then 30 % less pe rmeable than it s undraw n equi v alent . Such an effect ha s been ofte n reported fo r PE upon un iaxia l drawin g [\[64](#page-10-26) ,65], more scarcely upon sp ecifi c MD O pr ocessin g [22 ,66]. It has been explained by several phenomena caused by drawing: *i.* increase of th e degree of crystallinity, *ii .* increase of to rtuosit y throug h th e fragme ntation of lame lla e into smalle r crystallin e blocks , *iii.* in crease of density of the amorphous phase (hence decrease of f_a). In the pr esent case , no change of th e degree of crystallinit y wa s observed be twee n PE - 1 an d PE -4, so th e decrease of pe rmeabilit y upon drawin g would rather be owing to an enhancement of the tortuosity consecutive to th e MD O drawin g and/or a decrease in th e amorphou s phas e de nsity .

3. 2 . Effect of photooxidation on undraw n an d MD O -draw n PE films

3.2. 1 . Kinetics of photooxidation

To assess th e effect of MD O on th e ph otoox idation of polyet hylene, PE - 1 an d PE - 4 film s were expose d to ligh t irradi ation in th e SEPA P MH E device at 90 W m^{-2} up to 200 h and FTIR spectra were regularly recorded. The formation of several oxygen-containing functions resultin g from th e ph otoox idation of PE ca n be observed in th e 1900 - 1500 cm⁻¹ region ([Fig.](#page-6-0) 5): carboxylic acids (1713 cm⁻¹), esters (1735 cm^{-1}) and lactones (1780 cm^{-1}) , as well as alcohols and hydroperoxides (broad band with a maximum at 3420 cm^{-1}) [28]. The shape of the carbonyl envelop was identical for PE-1 and PE-4, which indicates that the stoichiometry of the oxidation products was not altered by the modification of the morphology and that the modifications induce d by th e MD O pr ocessin g (e specially th e chai n or ientation , *vide* supra) did not modify the photooxidation mechanism.

The difference of absorbance ΔA at 1713 cm⁻¹ (C=O symmetric stretching in carboxylic acids [41]) with respect to the unexposed film is plotte d as a function of ph otoox idation time in [Fig.](#page-6-1) 6 fo r both PE - 1 and PE-4. Thermal ageing experiments at 60 °C without light (dark control) fo r th e same time (200 h) di d no t show an y change in th e FTIR spectra, whic h ev idenced th e ph otochem ica l or igi n of th e ox idation mech anism at this time scale.

Despit e th e change in mo rpholog y an d th e or ientation of th e poly me r chains alon g th e MD caused by th e MD O drawing, no di ffe rence in th e ph otoox idation kine tic s wa s observed betwee n PE - 1 an d PE -4. This ca n be explaine d by th e occu rrenc e of an annealin g step du rin g th e MD O process. Indeed , it wa s reported that annealin g partly ca ncels th e be n eficial effect of or ientation on th e ph otost abi lit y of PE [38] . MD O

drawin g thus enhances se veral properties of PE , includin g it s capa cit y to ac t as a ba rrier to ox ygen, withou t degradin g it s durabi lity.

3.2. 2 . Change in crystallinity upon photooxidation

As can be seen in [Tabl](#page-7-0)e 5, a small variation of FWHM of the (110) an d (200) Brag g peak s as a function of th e ph otoox idation time wa s ob served within each series . It reveal s an increase in th e size of th e crysta l lites upon photooxidation, which is confirmed by the D_{ν} values calculate d from th e (110) an d (200) peak s afte r 20 0 h of ag eing.

The degree of crystallinity χ_c from DSC and XRD in the course of ph otoox idation is re presented in [Fig.](#page-7-1) 7 . As ca n be observed , it remain s co nstan t up to 10 0 h before a slight increase fo r both PE - 1 an d PE - 4 sa mples . This increase ma y be explaine d by th e chemicry sta llization proces s [[29](#page-10-4) [,67](#page-10-29)]: shorte r an d more mobile chains ar e pr oduce d by chai n scission s upon (photo)ag ein g in th e amorphou s region s an d ca n then crystallize. The increase of the crystallite size observed [\(Tabl](#page-7-0)e 5) is then in favo r of a chemicry sta llization proces s that woul d rather involv e th e thic kenin g of exis tin g crysta llite s rather than th e fo rmation of ne w ones. The similar increase of χ_c for both PE-1 and PE-4 is consistent with th e alik e kine tic s of ph otoox idation show n above.

Finally, 1D -SAXS pr ofile s were recorded on undraw n PE - 1 an d MDO-drawn PE-4 prior and after 200 h of photoageing [\(Fig.](#page-7-2) 8). A broad

peak is only observed fo r PE - 1 afte r 20 0 h of ph otoox idation . It indi cates a stacked lamellar structure for this sample, with a $\rm{q_{max}}$ value of about 0.257 nm⁻¹ leading to a long period $L_p = 2\pi/$ qmax = 24.5 nm. Give n th e smal l change s pr eviousl y observed in crysta llite size s an d de gree of crystallinity, this peak woul d be be tte r attributed to a reorgani zation of th e amorphou s part of th e polyme r upon ph otoag eing.

In addition, a small shoulder can be observed for PE-1 at 0 h. This migh t co rrespon d to th e long period an d Lorent z co rre ction wa s then applied in order to reveal it (insert of [Fig.](#page-7-2) 8). However, even with this co rre ction , it wa s no t po ssibl e to co nfirm th e presence of a peak fo r PE - 1 at 0 h becaus e of th e nois e on th e data points .

3.2. 3 . Modification of orientatio n upon photooxidation

No si gni ficant shift in th e XR D peak position of th e crystallin e part wa s observed fo r PE - 1 an d PE - 4 upon ph otoox idation (see result s in th e ESI). The $\rm I_{(200)}/I_{(110)}$ ratio slightly decreased within the first 50 h of ageing (*e.g.* from 1.18 to 1.07 for PE-4), but was then constant (Table S2).

Changes of the orientation function $f_{\rm c,MD}$ (as well as $f_{\rm a,MD}$ and $f_{\rm b,MD}$) were also eval uated du rin g th e ph otoox idation usin g th e absorbance of the IR bands at 720 and 730 cm^{-1} . Orientation functions with respect to the MD are plotted for a- and c-axis in [Fig.](#page-8-0) $9 \left(f_{b, \text{MD}} \right)$ being constant all along the photooxidation). The absence of any change in $f_{\rm b,MD}$ reveals that th e or ientation of this axis with respec t to th e MD wa s no t mo d ified by ph otoox idation .

It can be observed that $f_{\rm a,MD}$ and $f_{\rm c,MD}$ were slightly modified in opposite dire ction s afte r 50 h of ligh t exposure fo r both sa mples , before reaching a constant value up to the final photooxidation time.

The only changes in orientation (I₍₂₀₀₎/I₍₁₁₀₎ ratio, $f_{\rm a,MD}$ and $f_{\rm c,MD}$) occurred within th e firs t 50 h of ph otoox idation , whic h co rresponds to Δ A (1713 cm^{-1}) < 0.025. They cannot thus be explained by the photoagein g proces s bu t rather by some phys ica l ag ein g (*i.e.* reorganization of the amorphous part of the polymer which also affect the orientation of th e neig hbo rin g crystallin e part). This coul d occu r upon exposure to te mpe r ature (6 0 °C) into th e acce lerated ph otoag ein g device prio r to the onset of the photochemical ageing mechanism. The absence of any change afte r 50 h reveal s that th e ph otoox idation proces s does no t have an y effect on th e or ientation of th e crysta llites.

In addition, orientation of amorphous chains was studied upon photooxidation by calculating $f_{\rm c,MD}$ at 1368 and 1352 $\rm cm^{-1}$. Except for a smal l decrease at 50 h, no change wa s observed (Fig. S5 in th e ESI) .

3.2. 4 . Modification of permeability upon photooxidation

Despite the crucial role of this parameter in numerous applications, th e change of pe rmeabilit y upon ph otoag ein g ha s only received li ttl e attention up to now [68–76]. Fig. 10a shows the changes of the permeability coefficient P along photooxidation for both PE-1 and PE-4 (results for the dark control experiment are plotted in Fig. 10b).

As can be seen in Fig. 10, the permeability coefficient P slightly increase d du rin g th e firs t 50 h fo r both ph otochem ica l an d therma l ag e ing conditions. P remained then constant up to 200 h for thermal experiment s (Fig. 10b) , wherea s it li nearl y decrease d unde r ligh t exposure ([Fig.](#page-8-1) 10a). In the latter case, the decrease rate appears to be higher for PE-1 (−35 % from initial value after 200 h) than PE-4 (−25 %), to such an extent that P is clos e fo r both sa mples afte r 20 0 h. From th e poin t of view of ba rrier properties , thes e result s su ggest that ph otoox idation ha s a be n eficial role on PE ba rrier properties , as it pr ogressively reduce s th e permeability to oxygen. By comparing the change of P upon photooxidation to that during thermal ageing, it appears that the initial increase of th e ox yge n pe rmeabilit y (first 50 h) is rather a therma l effect than a photochemical one as it occurs in both cases. It may be associated to a slight reorganization induce d by phys ica l ag eing, whic h wa s pr eviousl y evidenced in the orientation experiments (*vide infra*). However, it is obviou s that th e decrease of P observed in a se con d time is of ph otochem i ca l or igin, as it only appeared in presence of light, an d is then a co nse quence of th e ph otoox idation process. Decrease in ox yge n pe rmeabilit y coul d caus e th e ph otoox idation to slow down or even stop becaus e of ox yge n starvation . Ne verth eless , thes e co ndition s ar e no t reache d here , as can be seen in the photooxidation kinetics of [Fig.](#page-6-1) 6.

Crysta llite s ar e so densel y packed that they ar e impe rmeable to ox y gen. As a co nsequence , pe rmeatio n an d then ph otoox idation ar e both restricted to th e amorphou s part of a polyme r [29,62]. From a ge neral poin t of view , an d as reported abov e in th e ma n uscript , ph otoox idation may affect the polymer structure in several ways: *i.* crystallinity could be mo d ified throug h chemicry sta llization [\[29](#page-10-4) [,67\]](#page-10-29), *ii .* pola r function s such as hydroxyls, carboxylic acids, esters, etc. are formed [28–[30\]](#page-10-3), *iii.* chain scissions can occur, which increase the macromolecular mobility, *iv*. crosslinks could appear [29]. All these effects would affect the permeabilit y of a polymer. Indeed , chemicry sta llization woul d caus e a de crease of both S (Eq. (7)) [62] an d D (i ncrease d to rtuosit y an d chai n im mobilization , Eq . (9)) [62 ,63]. Th e fo rmation of pola r groups ma y mo d ify th e inte raction s betwee n th e polyme r an d th e pe rmean t (chang e in χ_1 causing a modification of S_a , see Eq. [\(8](#page-6-4))) and the cohesion energy de nsity of th e polyme r (chang e in D) . Chai n scission s coul d ease th e di ffusion process, while crosslinking would have the opposite effect [60].

As presented above, the degree of crystallinity increases upon pho-toageing ([Fig.](#page-7-1) 7), while polar groups appeared within the polymer structure ([Fig.](#page-6-0) 5). Steric Exclusion Chromatography (SEC) analyses were pe rformed on PE - 1 an d PE - 4 at di ffe ren t stages of ph otoox idation (0 , 50 an d 20 0 h, se e result s in th e ESI) . Mass averag e mola r masses are initially similar for PE-1 and PE-4 (about 450 000 g mol⁻¹) and a high polydispersity was observed for both samples prior to ageing $(I_p = 27)$. High initial polydispersity was not surprising as the samples ar e co mpose d of di ffe ren t grades of LDPE an d LLDPE. Upon ph otoag e ing, th e same beha vio r is observed fo r PE - 1 an d PE -4: chromatogram s reveal a decrease of $\overline{\mathrm{M}}_{\mathrm{w}}$ up to 62 000 g mol $^{-1}$ after 200 h of photoageing, with a huge decrease of polydispersity (up to I $_{\rm p}$ = 7 at 200 h). This decrease of $M_{\rm w}$ clearly shows the occurrence of chain scissions, what is confirmed by the decrease of I_p . In addition, there is no evidence of any crosslin kin g upon ph otoag ein g as no si gna l of higher mola r mass wa s observed in th e chromatogram s an d no inso l ubl e fraction wa s detected in ge l fraction expe r iments.

Th e ma rgina l increase of th e degree of crystallinit y observed fo r both sa mples upon ph otoox idation woul d no t be able to explain, on it s own, the extent of the decrease of P with Eq. [\(7](#page-6-2)), so other factors might have an effect. The increase of tortuosity brought by the chemicrystallization proces s woul d be involved . Indeed , this ph eno m eno n involves , in the present case, the addition of short macromolecules resulting from chain scissions to existing crystallites, which could further hinder the diffusion of oxygen (Eq. [\(9](#page-6-3))). This effect may be more important for PE-1 whos e mo rpholog y is of spheruliti c nature than fo r PE - 4 co mpose d of fi brils co nst itute d by smal l crystallin e blocks co nnected by amorphou s chains an d whos e to rtuosit y is in itially higher . This woul d explai n th e higher decrease of P for PE-1 than PE-4. The formation of polar groups in ap ola r PE upon ph otoox idation woul d also pa rti c ipate to th e redu c tion of P. Indeed, this would hinder the interactions between PE and apolar oxygen (increased χ_1 causing a decrease of S_a , see Eq. [\(8](#page-6-4))), and increase th e cohesion energy de nsity of th e polyme r (r educe d D) . Th e co ntr ibution of chai n scission s to th e change in ox yge n pe rmeabilit y seem s mino r as P decreased. Ho wever , it is di fficult to di scrim inate thes e effect s as they occu r simu ltaneousl y du rin g th e ph otoox idation of PE and would not have the same relative impact on the change in permeability.

4. Conclusion

XR D an d pola rized FTIR spectroscopy showed that Machin e Dire c tion Orientation (MDO) drawing resulted in the transformation of the initial spherulitic structure of PE into an oriented fibrillar morphology co mpose d of fragmented crystallin e blocks linked by amorphou s chains or iente d alon g th e drawin g dire ction . No mo d ification of th e degree of crystallinit y wa s caused by th e MD O process, bu t a 30 % redu ction of th e ox yge n pe rmeabilit y wa s observed . This ca n be explaine d by an in crease of th e amorphou s phas e de nsity an d of th e to rtuosit y (cause d by th e smalle r crystallin e blocks resultin g from th e fragme ntation of th e in itial lame llae) in th e fi bri lla r mo rphology.

organic to consider the most consider the Undrawn (PE-1) and MDO-drawn (PE-4) films presented identical ph otoox idation kine tics. This coul d be attributed to th e annealin g step of th e MD O proces s whic h ca ncels th e reported be n eficial effect of or i entation on th e ph otost abi lit y of PE . Th e st o ichio m etr y of th e ox idation products wa s no t affected by th e change in mo rpholog y betwee n PE - 1 an d PE -4. Th e degree of crystallinit y of both sa mples increase d upon ph otoox idation owin g to th e chemicry sta llization mech anism , and, as th e crysta llite size increase d du rin g th e ph otoox idation process, it ca n be co ncluded that it occurred throug h th e growth of exis tin g crysta l lites. The polymer orientation slightly changed during the first 50 h of ph otoag eing, whic h coul d be du e to phys ica l ag eing, bu t then stayed co nstan t up to co mplet e ph otoox idation . Ox yge n pe rmeabilit y of both undraw n an d MD O -draw n film s showed a slight in itial increase (which coul d be also explaine d by phys ica l ag eing) fo llowe d by a co nti n uou s decrease du e to th e ph otoox idation process. Indeed , ph otoox idation ha s co nsequence s on th e chem ica l stru cture an d mo rpholog y of PE that coul d mo dify it s pe rmeability. Th e fo rmation of pola r functions, ev i denced by FTIR spectroscopy , woul d on on e hand increase th e polyme r cohesion energy de nsity an d on th e othe r hand reduce it s affi nit y with apolar molecular oxygen, resulting in a decrease of the oxygen permeability. Moreover , th e observed change in crystallinit y caused by chemicry sta llization woul d reduce th e amount of pe rmeable mate ria l (a s crystallin e region s ar e co nsi dered impe rmeable) an d increase th e to rtuosity, also redu cin g th e ox yge n pe rmeability. As fo r chai n scis sions, whic h were ev idenced upon ph otoox idation by SE C expe r iments, they woul d increase th e pe rmeability. Ho wever , they di d no t pr evail over th e increase in pola rit y an d th e chemicry sta llization proces s be caus e th e ox yge n pe rmeabilit y is , on th e whole, decrea sin g upon ph o tooxidation. It would be of great interest to distinguish between these effects on the permeability by considering polar permeants (such as water vapour) instead of apolar oxygen, as well as determine values of the

so l ubi lit y an d di ffusion coefficients upon ph otoox idation to assess if these steps are affected in the same manner upon photoageing.
